PROCEDURAL BACKGROUND

On, 2020, the Office of Legal Counsel, Regulations, and Administrative Hearings ("OLCRAH") received (the "Appellant") telephoned hearing request disputing the amount of Supplemental Nutrition Assistance Program ("SNAP") benefits he received from the Department of Social Services (the "Department").
On 2020, the OLCRAH scheduled the administrative hearing for 2020.
On 2020, in accordance with sections 17b-60, 17b-61 and 4-176e to 4-189, inclusive, of the Connecticut General Statutes, the OLCRAH held an administrative hearing. The following individuals participated in the proceeding:

STATEMENT OF ISSUE

2020.

The issue is whether the Department correctly determined the amount of the Appellant's 2020 SNAP benefits.

FINDINGS OF FACT

- 1. The Appellant is years old. (Dept. Exhibit 4)
- 2. The Appellant lives alone. (Appellant Testimony)
- 3. The Appellant pays \$550.00 per month in rent, paying for heat and utilities separately. (Appellant Testimony)
- 4. The Appellant grosses \$1,398.00 in Social Security benefits. (Dept. Exhibit 4)
- 5. On 2020, the Department issued the Appellant \$25.00 as his regular monthly SNAP benefit. (Dept. Exhibit 2)
- 6. On 2020, the Department issued the Appellant \$5.00 in SNAP benefits for Tropical Storm Isaias relief, equal to 20 percent of his \$25.00 regular monthly SNAP benefit. (Department Representative Testimony) (Dept. Exhibit 2)
- 7. On 2020, the Department issued the Appellant \$169.00 in SNAP benefits. (Dept. Exhibit 2)
- 8. In 2020, the maximum SNAP allotment for an individual without income was \$194.00, exclusive of the Tropical Storm Isaias emergency relief. (Department Representative Testimony)
- 9. Title 7, Code of Federal Regulations ("C.F.R.") 273.15 (c)(1) provides in part that "[w]ithin 60 days of receipt of a request for a fair hearing, the State agency shall assure that the hearing is conducted, a decision is reached, and the household and local agency are notified of the decision..." On 2020, the OLCRAH received the Appellant's telephoned hearing request. The issuance of this decision would have been due by 2020. This decision is timely.

CONCLUSIONS OF LAW

1. The Department of Social Services is the designated state agency for the administration of the supplemental nutrition assistance program pursuant to the Food and Nutrition Act of 2008. Conn. Gen. Stat. § 17b-2.

"The commissioner shall make periodic investigations to determine eligibility and may, at any time, modify, suspend or discontinue an award previously made when such action is necessary to carry out the provisions of the ... supplemental nutrition assistance program...." Conn. Gen. Stat. § 17b-80.

The Department has the authority to modify, suspend, or discontinue the Appellant's SNAP benefits to carry out the provisions of the SNAP.

2. Title 7, Code of Federal Regulations ("C.F.R.") section 273.1 (a)(3) provides that a household is "[a] group of individuals who live together and customarily purchase food and prepare meals together for home consumption."

As an individual living alone, the Appellant is a SNAP household of one.

3. "Household income shall mean all income from whatever source excluding only items specified in paragraph (c) of this section." 7 C.F.R. § 273.9 (b).

"Unearned income shall include, but not be limited to: (ii) Annuities; pensions; retirement, veteran's, or disability benefits; worker's or unemployment compensation including any amounts deducted to repay claims for intentional program violations as provided in §272.12; old-age, survivors, or social security benefits; strike benefits; foster care payments for children or adults who are considered members of the household; gross income minus the cost of doing business derived from rental property in which a household member is not actively engaged in the management of the property at least 20 hours a week." 7 C.F.R. § 273.9 (b)(2)(ii).

4. Title 7, Section § 273.9 (d)(1)(i) of the Code of Federal Regulations provides for a standard deduction for the 48 States, District of Columbia, Alaska, Hawaii, and the Virgin Islands.

The SNAP Standard Deduction is \$167.00 per month for a household of one, effective October 1, 2019.

For the purposes of the SNAP, the Appellant is eligible for the \$167.00 per month standard deduction.

For 2020, the Appellant's adjusted monthly gross income equaled \$1,231.00, or \$1,398.00 (Social Security) minus \$167.00 (standard deduction).

- 5. Title 7, Section 273.10 (e) of the Code of Federal Regulations provides for calculating net income and benefit levels. Subsection (e)(1)(i) provides:
 - To determine a household's net monthly income, the State agency shall:
 - (A) Add the gross monthly income earned by all household members and the total monthly unearned income of all household members, minus income exclusions, to determine the household's total gross income...
 - (B) ...
 - (C) Subtract the standard deduction.
 - (D) ...
 - (E) ...
 - (F) ...
 - (G) ...
 - (H) Total the allowable shelter expenses to determine shelter costs, unless a deduction has been subtracted in accordance with paragraph (e)(1)(i)(G) of this section. Subtract from total shelter costs 50 percent of the household's monthly income after all the above deductions have been subtracted. The remaining amount, if any, is the excess shelter cost. If there is no excess shelter cost, the net monthly income has been determined. If there is excess shelter cost, compute the shelter deduction according to paragraph (e)(1)(i)(I) of this section.
 - (I) Subtract the excess shelter cost up to the maximum amount allowed for the area (unless the household is entitled to the full amount of its excess shelter

expenses) from the household's monthly income after all other applicable deductions. Households not subject to a capped shelter expense shall have the full amount exceeding 50 percent of their net income subtracted. The household's net monthly income has been determined.

7 C.F.R. § 273.10 (e)(1)(i).

"Excess shelter deduction. Monthly shelter expenses in excess of 50 percent of the household's income after all other deductions in paragraphs (d)(1) through (d)(5) of this section have been allowed. If the household does not contain an elderly or disabled member, as defined in §271.2 of this chapter, the shelter deduction cannot exceed the maximum shelter deduction limit established for the area...." 7 C.F.R. § 273.9 (d)(6)(ii).

The cap on shelter hardship for SNAP households containing no elderly or disabled members is \$569.00.

For the purposes of the SNAP, the Appellant is not subject to the shelter hardship cap, as he is over the age of 60 years.

6. "With FNS approval, a State agency may develop the following standard utility allowances (standards) to be used in place of actual costs in determining a household's excess shelter deduction: an individual standard for each type of utility expense; a standard utility allowance for all utilities that includes heating or cooling costs (HCSUA); and, a limited utility allowance (LUA) that includes electricity and fuel for purposes other than heating or cooling, water, sewerage, well and septic tank installation and maintenance, telephone, and garbage or trash collection...." 7 C.F.R. § 273.9 (d)(6)(iii)(A).

Effective October 1, 2019, the standard utility allowance ("SUA") in Connecticut equaled \$736.00 per month.

For the purposes of the SNAP, the Appellant's monthly shelter costs equal \$1,286.00. [\$550.00 (rent) + \$736.00 (SUA)]

For the purposes of the SNAP, the Appellant's shelter hardship equals \$670.50. [\$1,286.00 monthly shelter costs) minus \$615.50 (50% of adjusted gross income)]

7. Title 7, Section 273.10 (e)(4) of the Code of Federal Regulations addresses the Thrifty Food Plan and maximum SNAP allotments.

The Thrifty Food Plan for a qualified assistance unit of one in Connecticut with no applied income equals \$194.00 per month, effective October 1, 2019.

Title 7, Section 273.10 (e)(2)(ii)(A) of the Code of Federal Regulations provides: Except as provided in paragraphs (a)(1), (e)(2)(iii) and (e)(2)(vi) of this section, the household's monthly allotment shall be equal to the maximum SNAP allotment for the household's size reduced by 30 percent of the household's net monthly income as calculated in paragraph (e)(1) of this section. If 30 percent of the household's net income ends in cents, the State agency shall round in one of the following ways:

- (1) The State agency shall round the 30 percent of net income up to the nearest higher dollar; or
- (2) The State agency shall not round the 30 percent of net income at all. Instead, after subtracting the 30 percent of net income from the appropriate Thrifty Food Plan, the State agency shall round the allotment down to the nearest lower dollar.

7 C.F.R. § 273.10 (e)(2)(ii)(A).

The Appellant's regular SNAP benefits for the follows:

The Department correctly determined that the Appellant's regular SNAP amount equaled \$25.00 per month, by incorporating his income and allowable shelter costs.

9. <Field Operations Communication, Elizabeth Thomas, 9/1/2020> notifies Department staff that the federal Food and Nutrition Service approved two waivers for SNAP recipients in Connecticut associated with Tropical Storm Isaias. The Communication notifies staff that SNAP Replacement Benefits of 20 percent of eligible households' SNAP benefits would be issued to those household who had not already received a manual replacement issuance by September 3, 2020.

The Department correctly issued \$5.00 to the Appellant in 2020 as Tropical Storm Isaias relief, based on a percentage of his regular SNAP amount of \$25.00 per month. [\$25.00 (Appellant's regular monthly SNAP amount) multiplied by 20 percent = \$5.00]

10. < Field Operations Communication, Elizabeth Thomas, 20> in part notifies Department staff that the Department would provide Emergency SNAP supplements on September 16, 2020, as authorized by the federal Families First Coronavirus Responses Act of 2020. The Communication notifies staff that the Emergency SNAP supplement would be the difference between what the household received in the formula of the maximum benefit amount for their household size.

The Department correctly issued \$169.00 to the Appellant his Emergency SNAP supplement in 2020. [\$194.00 (maximum amount for an individual with no income) minus \$25.00 (Appellant's regular monthly SNAP amount)]

The Department correctly determined the amount of the Appellant's 2020 SNAP benefits, or \$199.00, which incorporates his regular SNAP benefit (\$25.00), his Tropical Storm Isaias relief (\$5.00), and the emergency supplemental allotment (\$169.00) as authorized by the federal Families First Coronavirus Responses Act of 2020.

DECISION

The Appellant's appeal is DENIED.

RIGHT TO REQUEST RECONSIDERATION

The Appellant has the right to file a written reconsideration request within 15 days of the mailing date of the decision on the grounds there was an error of fact or law, new evidence has been discovered or other good cause exists. If the request for reconsideration is granted, the Appellant will be notified within 25 days of the request date. No response within 25 days means that the request for reconsideration has been denied. The right to request a reconsideration is based on § 4-181a (a) of the Connecticut General Statutes.

Reconsideration requests should include <u>specific</u> grounds for the request: for example, indicate <u>what</u> error of fact or law, <u>what</u> new evidence, or <u>what</u> other good cause exists.

Reconsideration requests should be sent to: Department of Social Services, Director, Office of Legal Counsel, Regulations, and Administrative Hearings, 55 Farmington Avenue, Hartford, CT 06105.

RIGHT TO APPEAL

The Appellant has the right to appeal this decision to Superior Court within 45 days of the mailing of this decision, or 45 days after the agency denies a petition for reconsideration of this decision, provided that the petition for reconsideration was filed timely with the Department. The right to appeal is based on § 4-183 of the Connecticut General Statutes. To appeal, a petition must be filed at Superior Court. A copy of the petition must be served upon the Office of the Attorney General, 55 Elm Street, Hartford, CT 06106 or the Commissioner of the Department of Social Services, 55 Farmington Avenue, Hartford, CT 06105. A copy of the petition must also be served on all parties to the hearing.

The 45-day appeal period may be extended in certain instances if there is good cause. The extension request must be filed with the Commissioner of the Department of Social Services in writing no later than 90 days from the mailing of the decision. Good cause circumstances are evaluated by the Commissioner or his designee in accordance with § 17b-61 of the Connecticut General Statutes. The Agency's decision to grant an extension is final and is not subject to review or appeal.

The appeal should be filed with the clerk of the Superior Court in the Judicial District of New Britain or the Judicial District in which the Appellant resides.
