


PROCEDURAL BACKGROUND




STATEMENT OF THE ISSUE

The issue to be decided is whether the Department correctly discontinued the Appellant's SNAP benefits, effective 2022, for failure to complete a redetermination.

FINDINGS OF FACT								
1.	On 2021, the Department issued the Appellant a W-1ERL Renewal of Eligibility notice ("Renewal Notice"). The notice reflected the SNAP certification period that began on 2021, was ending or 2021. The notice stated, "You must complete your form and submit all required proofs by 2021 or your benefits may stop." (Exhibit 7: Renewal Notice)							
2.	On 2021, the Department received a completed Online Renewa form ("ONRE"). The Appellant reported receipt of other income from in the amount of \$150 twice per month. (Exhibit 5: Document Search; Exhibit 8: ONRE; Department's Testimony)							
3.	On 2021, the Department reviewed the ONRE. The Department determined the Appellant reported changes. The changes were not updated in ImpaCT, the Department's online eligibility system. The case note directed the worker to review and update the Appellant's income (Exhibit 1: Case notes)							
4.	On 2021, the Department reviewed the Appellant's SNAF renewal form and issued the Appellant a W-1348: Proofs We Need form ("W-1348") requesting proof of money received from stating how much and how often (letter or equivalent) due by 2021. (Exhibit 3: W-1348)							
5.	On 2021, the Department issued the Appellant a W-3015N Interview Notice requesting the interview be completed by 2021. The Interview Notice stated, "Your benefits will end if you do not have your interview and send us all of the required proofs we asked for by the benefit closure date(s)." (Exhibit 4: Interview Notice)							
6.	On Solution 2021, the Department issued the Appellant a W-0108N Notice of Missed Interview ("NOMI"). The NOMI stated, "This is a reminder that you need to have an interview in order to keep getting the following benefits from DSS: Program(s): SNAP." The NOMI also stated, "If you do not have your interview and send in all of the required proofs by the benefit closure date, your benefits will end on the benefit closure date." (Exhibit 6 Notice of Missed Interview)							





10. The issuance of this decision is timely under Connecticut General Statutes 17b-61(a), which requires that a decision be issued within 60 days of the request for an administrative hearing. The hearing request was received on 2022; therefore, this decision is due no later than 2022.

CONCLUSIONS OF LAW

- Connecticut General Statutes § 17b-2 provides that the Department of Social Services is designated as the state agency for the administration of (7) the supplemental nutrition assistance program pursuant to the Food and Nutrition Act of 2008.
- 2 Title 7 of the Code of Federal Regulations ("C.F.R") § 273.10(f) provides the following: Certification periods. The State agency must certify each eligible household for a definite period of time. State agencies must assign the longest certification period possible based on the predictability of the household's circumstances. The first month of the certification period will be the first month for which the household is eligible to participate. The certification period cannot exceed 12 months except to accommodate a household's transitional benefit period and as specified in paragraphs (f)(1) and (f)(2) of this section.

The Department complied with Federal Regulation and correctly determined the Appellant eligible for a 12 month SNAP certification period with a begin date of 2021, and an end date of 2021.

3. 7 C.F.R § 273.14(a) provides the following: *General.* No household may participate beyond the expiration of the certification period assigned in accordance with §273.10(f) without a determination of eligibility for a new period. The State agency must establish procedures for notifying households

of expiration dates, providing application forms, scheduling interviews, and recertifying eligible households prior to the expiration of certification periods. Households must apply for recertification and comply with interview and verification requirements.

4. 7 C.F.R § 273.14(b)(1)(i) provides the following: The State agency shall provide households certified for one month or certified in the second month of a two-month certification period a notice of expiration (NOE) at the time of certification. The State agency shall provide other households the NOE before the first day of the last month of the certification period, but not before the first day of the next-to-the-last month. Jointly processed PA and GA households need not receive a separate SNAP notice if they are recertified for SNAP benefits at the same time as their PA or GA redetermination.

- 5. 7 C.F.R § 273.14(b)(2) provides the following: *Application*. The State agency must develop an application to be used by households when applying for recertification. It may be the same as the initial application, a simplified version, a monthly reporting form, or other method such as annotating changes on the initial application form. A new household signature and date is required at the time of application for recertification. The provisions of § 273.2(c)(7) regarding acceptable signatures on applications also apply to applications used at recertification. The recertification process can only be used for those households which apply for recertification prior to the end of their current certification period, except for delayed applications as specified in paragraph (e)(3) of this section. The process, at a minimum, must elicit from the household sufficient information that, when added to information already contained in the casefile, will ensure an accurate determination of eligibility and benefits. The State agency must notify the applicant of information which is specified in § 273.2(b)(2), and provide the household with a notice of required verification as specified in § 273.2(c)(5).
- 6. 7 C.F.R § 273.2(c)(7) provides the following: Signing an application or reapplication form. In this paragraph, the word "form" refers to applications and reapplications.
- 7. 7 C.F.R § 273.2(c)(7)(i) provides the following: Requirement for a signature. A form must be signed to establish a filing date and to determine the State agency's deadline for acting on the form. The State agency shall not certify a household without a signed form.

The Appellant complied with Federal Regulation by submitting an electronically signed online renewal form received by the Department on 2021.

- 8. 7 C.F.R § 273.2(f)(8)(i)(A) provides the following: At recertification the State agency shall verify a change in income if the source has changed or the amount has changed by more than \$50. Previously unreported medical expenses, actual utility expenses and total recurring medical expenses which have changed by more than \$25 shall also be verified at recertification. The State agency shall not verify income if the source has not changed and if the amount is unchanged or has changed by \$50 or less, unless the information is incomplete, inaccurate, inconsistent or outdated. The State agency shall also not verify total medical expenses, or actual utility expenses claimed by households which are unchanged or have changed by \$25 or less, unless the information is incomplete, inaccurate, inconsistent or outdated. For households eligible for the child support deduction or exclusion, the State agency may use information provided by the State CSE agency in determining the household's legal obligation to pay child support, the amount of its obligation and amounts the household has actually paid if the household pays its child support exclusively through its State CSE agency and has signed a statement authorizing release of its child support payment records to the State agency. A household would not have to provide any additional verification unless they disagreed with the information provided by the State CSE agency. State agencies that choose to use information provided by their State CSE agency in accordance with this paragraph (f)(8)(i)(A) must specify in their State plan of operation that they have selected this option. For all other households eligible for the child support deduction or exclusion, the State agency shall require the household to verify any changes in the legal obligation to pay child support, the obligated amount, and the amount of legally obligated child support a household member pays to a nonhousehold member. The State agency shall verify reportedly unchanged child support information only if the information is incomplete, inaccurate, inconsistent or outdated.
- 9. 7 C.F.R § 273.14(b)(4) provides the following: Verification. Information provided by the household shall be verified in accordance with § 273.2(f)(8)(i). The State agency shall provide the household a notice of required verification as provided in § 273.2(c)(5) and notify the household of the date by which the verification requirements must be satisfied. The household must be allowed a minimum of 10 days to provide required verification information. Any household whose eligibility is not determined by the end of its current certification period due to the time period allowed for submitting any missing verification shall receive an opportunity to participate, if eligible, within 5

working days after the household submits the missing verification and benefits cannot be prorated.

The Department complied with Federal Regulation and correctly issued the Appellant a W-1348 requesting proof of his income. The due date of 2021, afforded the Appellant ten days to provide said information.

10. 7 C.F.R § 273.14(b)(3) provides the following: *Interview*. As part of the recertification process, the State agency must conduct an interview with a member of the household or its authorized representative at least once every 12 months for households certified for 12 months or less. The provisions of § 273.2(e) also apply to interviews for recertification. The State agency may choose not to interview the household at interim recertifications within the 12-month period. The requirement for an interview once every 12 months may be waived in accordance with § 273.2(e)(2).

The Department complied with Federal Regulation and correctly issued the Appellant an Interview Notice on 2021.

The Department issued the Appellant a NOMI on 2021.

The Appellant completed the required TI on 2021.

- 11. 7 C.F.R § 273.2(f)(2)(i) provides the following: The State agency shall verify, prior to certification of the household, all other factors of eligibility which the State agency determines are questionable and affect the household's eligibility and benefit level. The State agency shall establish guidelines to be followed in determining what shall be considered questionable information. These guidelines shall not prescribe verification based on race, religion, ethnic background, or national origin. These guidelines shall not target groups such as migrant farmworkers or American Indians for more intensive verification under this provision.
- 12 7 C.F.R § 273.14(e)(2) provides the following: If a household files an application before the end of the certification period, but fails to take a required action, the State agency may deny the case at that time, at the end of the certification period, or at the end of 30 days. Notwithstanding the State's right to issue a denial prior to the end of the certification period, the household has 30 days after the end of the certification period to complete the process and have its application be treated as an application for recertification. If the household takes the required action before the end of the certification period, the State agency must reopen the case and provide a full month's benefits for the initial month of the new certification period. If the household takes the required action after the end of the certification period but within 30 days after the end of the certification period, the State agency

shall reopen the case and provide benefits retroactive to the date the household takes the required action. The State agency shall determine cause for any delay in processing a recertification application in accordance with the provisions of § 273.3(h)(1).

The Department needed proof of the Appellant's income to complete the SNAP redetermination and establish eligibility for a new certification period.

The Appellant did not provide proof of his income timely.

The Department correctly discontinued the Appellant's SNAP benefits effective 2022.

DECISION

The Appellant's appeal is **DENIED**.

RIGHT TO REQUEST RECONSIDERATION

The appellant has the right to file a written reconsideration request within **15** days of the mailing date of the decision on the grounds there was an error of fact or law, new evidence has been discovered or other good cause exists. If the request for reconsideration is granted, the appellant will be notified within **25** days of the request date. No response within 25 days means that the request for reconsideration has been denied. The right to request a reconsideration is based on § 4-181a (a) of the Connecticut General Statutes.

Reconsideration requests should include <u>specific</u> grounds for the request: for example, indicate <u>what</u> error of fact or law, <u>what</u> new evidence, or <u>what</u> other good cause exists.

Reconsideration requests should be sent to: Department of Social Services, Director, Office of Administrative Hearings and Appeals, 55 Farmington Avenue Hartford. CT 06105.

RIGHT TO APPEAL

The appellant has the right to appeal this decision to Superior Court within **45** days of the mailing of this decision, or **45** days after the agency denies a petition for reconsideration of this decision, provided that the petition for reconsideration was filed timely with the Department. The right to appeal is based on § 4-183 of the Connecticut General Statutes. To appeal, a petition must be filed at Superior Court. A copy of the petition must be served upon the Office of the Attorney General, 165 Capitol Avenue, Hartford, CT 06106 or the Commissioner of the Department of Social Services, 55 Farmington Avenue Hartford, CT 06105. A copy of the petition must also be served on all parties to the hearing.

The 45 day appeal period may be extended in certain instances if there is good cause. The extension request must be filed with the Commissioner of the Department of Social Services in writing no later than 90 days from the mailing of the decision. Good cause circumstances are evaluated by the Commissioner or the Commissioner's designee in accordance with § 17b-61 of the Connecticut General Statutes. The Agency's decision to grant an extension is final and is not subject to review or appeal.

The appeal should be filed with the clerk of the Superior Court in the Judicial District of New Britain or the Judicial District in which the appellant resides.
