## COVID-19 Agency Update September 4, 2020

The Department of Veterans Affairs (DVA) Healthcare Center (HCC) has no COVID-19 positive Veteran Patients in its Isolation and Recovery Unit and there have been no new Veteran Patients testing positive for COVID-19 in several months. As part of the DVA's rigorous COVID-19 mitigation procedures, over the previous three Mondays all Veteran Patients, including those in the Isolation Unit, have been tested for COVID-19 with all testing negative each time. There are six Veteran Patients in the HCC Isolation Unit, all of whom have tested negative for the virus, however as they are new admissions or patients who recently returned from an acute care facility, they will remain in the Isolation Unit until cleared by clinical staff for release after additional COVID-19 tests and monitoring.

The DVA Residential Facility has no COVID-19 positive Veteran Residents in its Isolation Recovery Unit and no new Veteran Residents have tested positive for COVID-19 in three months. The DVA Residential Facility completed a full one day testing of all Residential Veterans on July 21<sup>st</sup> with all Veterans testing negative for COVID-19 and all Veteran Residents will be tested again on September 9<sup>th</sup> as part of our COVID-19 mitigation efforts. Every Thursday since July 9th, the DVA conducted COVID-19 testing of all direct care and front-line staff with one asymptomatic HCC staff member testing positive just over two weeks ago. That person was immediately placed on administrative leave and any Veteran Patients identified through contact tracing were moved to the Isolation Unit as a precaution. These Veteran patients have all tested negative for the virus on three occasions since then. The testing results to date and the DVA's response to any positive tests demonstrate that our COVID-19 mitigation protocols, including wearing masks, screening and ongoing testing are keeping our Veterans and staff safe. Testing of DVA staff will continue weekly until further notice to mitigate the potential spread of the virus.

To date the DVA has tested over two hundred and thirty Veteran Residents and Patients (most tested multiple times) for COVID-19 with twenty-five testing positive, most of these early in the pandemic. Of the twenty-five Veteran Residents and Patients who tested positive, twenty-two recovered from the virus. One Veteran Resident and two Veteran Patients passed away in late April and early May due to COVID-19 complications. Six staff members have tested positive for COVID-19 since the beginning of the pandemic, with five recovering and returning to work and one who remains on leave consistent with CDC and DPH return to work guidelines.
