Call to Order

John Elsesser, Chair, called the meeting to order at 10:30 a.m.

Approval of the minutes

Bob Guthrie made a motion to approve the minutes of April 17, 2024. Jeff Morrisette seconded the motion. The minutes were approved.

PSDN Refresh

John Masciadrelli reported that Juniper equipment has been installed, powered on and is currently being managed by the BITS team at 178 PSDN locations. The BITS's network team continues to work on step-by-step instructions for migrating the various services and applications operating on the legacy network to the refreshed network. DSET/BITS did experience a couple of minor bumps in the road when utilizing the new software purchased for provisioning circuits on the new network. The software vendor (Anuta) quickly resolved the issues. On 8/14 the BITS team migrated 911 services off the legacy system and onto the refresh

system at DSET. The migration was seamless, and 911 services were not affected. This potential means 911 calls will not need to be rerouted during the switch to the new network.

During testing BITS experienced a couple of network issues that they were not pleased with. BITS and the network vendor are in the process of making the necessary corrections before moving forward with additional testing at DSET.

Application Status Report

John Masciadrelli reported that to date, the 222 PSDN requests that have been submitted to the PSDN Governance Board are in the pre-approval stage or have been approved and are operating on the PSDN. 198 of those requests have been raised, reviewed, and voted on by the board. All 198 requests have been approved to operate on the PSDN and to date, there are 188 requests operating on the PSDN. There are ten additional requests awaiting an implementation date or in the process of being implemented, and the remaining requests are in various stages of the connection process.

Application Review and Approval

John Masciadrelli presented request NM18669, the town of Wolcott is requesting layer 2 circuits from the town hall to Wolcott PD and Wolcott Fire Company # 1 and #2. The circuits will be used to support the town's public safety radio system. Bob Guthrie made a motion to approve the request, Ralf Calciano seconded the motion. Request NM18669 was voted on and approved.

John Masciadrelli presented request NM18682, Litchfield County Dispatch (LCD) is requesting a circuit on the PSDN to provide a direct link between LCD and Plymouth PD. This will allow LCD to export active Computer Aided Dispatch (CAD) data to Plymouth's CAD from the new NEXGEN upgrade. Brian Mirizzi requested adding Winsted PD to LCD's request. Mr. Masciadrelli requested an amendment to PSDN request NM18682 to include Winsted PD. John Elsesser made a motion to amend request NM18682, Jeff Morrisette seconded the motion. The amendment was voted on and approved. John Elsesser made a motion to approve the amended request NM18682, Jeff Morrisette seconded the motion. Request NM18682 was voted on and approved.
