Application Status Report

John Masciadrelli reported that to-date there have been 195 PSDN requests submitted to the PSDN Governance Board that are in the pre-approval stage or have been approved and are operating on the PSDN. 181 of those requests have been raised, reviewed and/or voted on by the board. All 181 requests have been approved to operate on the PSDN. Mr. Masciadrelli reported that to-date there are 170 requests operating on the PSDN. There are 10 additional requests awaiting an implementation date or are in the process of being implemented. The remaining requests are in various stages of the connection process.

Application Review and Approval

John Masciadrelli presented request NM18295 Connecticut Telecommunications System is requesting access to the PSDN to provide a circuit between an engineering test facility located at Brainard Airport to the Connecticut Land Mobile Radio Network's (CLMRN) Core. The circuit will enable CTS engineers the ability to monitor and program State radio assets from the testing facility. Bob Guthrie made a motion to approve NM18295. Jeff Morrissette seconded the motion. Request NM18295 was voted on and approved.

John Masciadrelli presented request NM18296 amendment to application NM14023. DESPP IT's original request was for connections on the PSDN, allowing DOT traffic camera access, at the State EOC and Troop's L and A. Providing access to the DOT cameras will enable the EOC and Connecticut State Police the ability to monitor for hazardous road conditions, traffic congestion and accidents. This request was approved by the governance board in 2014. PSDN request MN18296 is to provide PSDN circuits to the following three CSP troops: Troop E, Troop F and Troop I, enabling them to monitor the DOT traffic cameras. Jeff Morrisette made a motion to approve NM18296. Bob Guthrie seconded the motion. Request NM18296 was voted on and approved.
