Overview

- Connecticut is expected to receive over \$600 million over 18 years as part of the nationwide opioid litigation settlement agreements with various pharmaceutic distributors and opioid manufacturers
- Proceeds will be spent on substance use disorder abatement infrastructure, programs, services, supports, and resources for prevention, treatment, recovery, and harm reduction with public involvement, transparency, and accountability
- As of November 19th, the State has received a total of \$158,299,575, with funding recommendations having passed for \$21,867,871 leaving a balance in the fund of \$136,431,704.



Overview of Opioid Settlement Advisory Committee (OSAC)

- The Opioid Settlement Advisory Committee (OSAC) was established to ensure the proceeds received by the state are allocated appropriately
- OSAC is comprised of:
 - State and municipality representatives
 - Treatment providers
 - Persons or family members with lived experience
- Opioid Remediation Recommendations are provided by various community organizations and groups to OSAC, who vets the recommendations via specialty committees, followed by a vote by OSAC members to approve the recommendations



Opioid Settlement Funding Recommendation Process

- Recommendations for consideration for Opioid Settlement Funding can be submitted to <u>OSAC@ct.gov</u>
- Recommendations for Opioid Settlement Funding will be sent to the appropriate Alcohol and Drug Policy Council (ADPC) subcommittee for review by subject matter experts. If deemed to be appropriate, the recommendation will be vetted and voted on by OSAC
- Funding recommendations are funding suggestions, not applications for funding. Submissions do not guarantee that the submitter will receive funding. If the recommendation is approved by OSAC, it may result in a Request for Proposals to apply for funding



Municipalities and other Partners

- DMHAS works in partnership with other state agencies on implementation of the approved recommendations
- Other settling parties in Connecticut, such as municipalities and tribal governments, receive their proceeds directly from the settlement administrator and report yearly receipts and expenditures to the state to publish on the OSAC website

Promote and Expand Opioid Overdose Education and Prevention in CT's Colleges and Universities Approved November 2024

- Technical assistance to support opioid overdose education and prevention while simultaneously developing and/or enhancing recovery friendly communities at Connecticut institutions of higher education including:
 - Monthly interactive learning cohorts for faculty/staff and students/family members/community
 - Personalized technical assistance requested by any participating institution to address individualized capacity building needs around the topic of opioids and overdose prevention
- All CT Colleges and Universities are invited to participate
- Total funding amount (2.5 years): \$631,777
