SUBLOCADE® (buprenorphine extended-	Presentation from Indivior team.	
release) injection: Frank Caputo	 Sublocade Drug product overview: extended release buprenorphine that is injected 1x per month. Medication is contained in a gel which turns into a solid depot the size of pencil eraser that is injected into the stomach 1x/month. This medication works by blocking the euphoric effects of opioid drugs. Criminal Justice implications-helpful with re-entry to assist with any barriers/gaps in discharge from the facility to linkage to community program. Medication can last for 2-5 months of receptor occupancy and can assist in overdose prevention. Benefits include steady medication levels, 1x/month vs. daily need to take medications. This long-acting levels above 2 ng/ml meaning they will not experience withdrawal symptoms and cannot feel the euphoric effect (this will continue when discontinued as well, the gradual reduction effect will assist with withdrawal for about 5 months). Can remain detectable after it has been discontinued for up to 12 months in blood and urine drug screen. It will show decreasing levels but it will be a slow trending down.
