First Selectman Marconi will be attending out CJ meeting and any recommendations that come through will be reviewed via the ADPC subcommittees as the ADPC subcommittees will be the content experts and will review allocation/recommendations of funds. OSAC will be looking for recommendations from EBP to recommend to the full committee for programming funding.
