<b>DMHAS Crisis Services Presentation</b>	<p>Mobile Crisis Services</p> <ul style="list-style-type: none"><li>• 18 statewide teams (some DMHAS operated).</li><li>• Services are mobile, readily accessible, rapid response, and short-term for adults experiencing a mental health, substance-use, or co-occurring crisis.</li><li>• Availability of in-person response varies across the state.</li><li>• 90% of 2019 adults received a referral to ongoing interventions.</li></ul> <p>ACTION Line Services</p> <ul style="list-style-type: none"><li>• Offers statewide 24/7 centralized crisis call center (telephonic support) for adults experiencing an emotional crisis needing an immediate response.</li></ul> <p>Crisis Intervention Teams (CIT)/Training</p> <ul style="list-style-type: none"><li>• CIT model training is available to law enforcement and behavioral health personnel</li><li>• Provides knowledge and resources to connect adults experiencing crisis with supports and services</li><li>• Diverts adults from arrest, incarceration, and hospitalization.</li></ul> <p>Collaboration with Mobile Crisis and Law enforcement</p> <ul style="list-style-type: none"><li>• Some clinicians do ride-alongs with law enforcement some carry a police radio, or some are embedded with law enforcement</li><li>• There is regular communication, review of data, and training.</li></ul>	<ul style="list-style-type: none"><li>• Sandra will connect presenters to parole to do presentation.</li><li>• Sub-committee should consider the opportunity to partner with DMHAS, mobile crisis services, and law enforcement to review and provide training to law enforcement.</li></ul>

	<ul style="list-style-type: none"> <li>Quarterly CIT coordinators, clinicians, and DMHAS participate in learning collaboratives.</li> </ul> <p>Data-Next Steps</p> <ul style="list-style-type: none"> <li>In June 2021, 4,685 substance use related calls and 4,490 mental health related calls were received.</li> <li>Data around racial inequities related to access, outcomes, and implications of mobile crisis interventions will be explored and enhanced.</li> <li>Data will be reviewed taking into consideration the current continuum of services. Gaps and challenges have been identified (lack of stabilization beds, in-person response, etc.).</li> <li>Training and collaborations will be continued and enhanced.</li> </ul>	
<b>ESI Update</b>	Additional court cases are making the overall increasing the ESI work. Resource counselor and prosecutors continue to screen and divert cases and reduce court appearances.	<ul style="list-style-type: none"> <li>The sub-committee will consider an updated ESI presentation in a future meeting.</li> </ul>
<b>Narcan at DOC Update</b>	<ul style="list-style-type: none"> <li>Families and inmates continue to receive Narcan training/kits.</li> <li>Mailing of Narcan kits - no updates</li> </ul>	
<b>MAT at DOC Update</b>	<ul style="list-style-type: none"> <li>Cybulski now for offers MAT.</li> <li>Walker will offer MAT in September 2021.</li> <li>DOC is dosing approximately 500 inmates daily.</li> </ul>	
<b>Workgroup Updates</b>	<ul style="list-style-type: none"> <li>Tri-chairs met with workgroup leads to plan a report out and next steps for their workgroups.</li> <li>Police/Training - postponed</li> <li>Community Resources - postponed</li> </ul>
