SENIOR SERVICES

- a. The Contractor shall provide substance abuse services to individuals who are age fifty-five (55) and older. Such services shall include public information presentations and visits to home, hospitals, Senior centers, nursing homes, and Senior housing complexes. Services shall include detoxification and treatment services as indicated. Services shall be developed with the full participation of the service recipients.
- b. The Contractor shall provide services which meet the required utilization rate for this service. The minimum acceptable utilization rate for Senior Services is 90% of the number of services proposed per the approved funding application. Such information shall be verified by the Department.
- c. The Contractor shall implement the programs and services described herein to result in the following outcomes on behalf of individuals served. Such outcomes shall be measured in the manner described herein. Outcome results achieved pursuant to these terms and conditions will be monitored by the Department through data reported by the Contractor to the Department's information systems, in observations through site visits and/or in any other required reports. The Department's outcome indicators for the Contractor's funded services are as follows:
