

### Introduction

The Evaluation, Quality Management and Improvement (EQMI) Division at the Department of Mental Health and Addiction Services (DMHAS) is pleased to publish its eleventh Annual Statistical Report.

This report makes key information more accessible to departmental stakeholders and the public: it includes data on clients served, demographic characteristics, types of services provided, residential and inpatient bed utilization, and substance use trends.

It is important to note that this report covers Fiscal Year 2024 (July 1, 2023 – June 30, 2024).

This report utilizes data downloaded from DMHAS' Enterprise Data Warehouse on October 23, 2024.



### **About the Data in this Report**

The numbers contained in this report are the official DMHAS data for State Fiscal Year 2024 (SFY24).

These data include clients served in DMHAS-funded or DMHAS-operated programs. The clients and the services are diverse, and the data are complex. This report will, at different times, reflect numbers that refer to different subgroups or events that are based on specific filtering of the data.

For instance, we frequently filter out programs that are not required to report treatment data when we present information from the Level of Care (LOC) perspective. We also distinguish between clients and episodes. This distinction is important.



Each client may have multiple episodes of care that occur within the fiscal year; thus, the client may be counted multiple times (i.e. duplicated) – once for each episode, if applicable.

Thus, admissions and discharges are reported as episode counts, as many clients have multiple episodes. In addition, a client may be admitted to/enrolled in several programs simultaneously; therefore, each admission will be included in the overall Admission count.


The data contained in this report were downloaded from DMHAS' Enterprise Data Warehouse (EDW) on October 23, 2024. The data warehouse is a dynamic system, so reports or other analyses performed on different dates may produce slightly different results. Several levels of care (LOCs) are not included in these analyses, including Pre-Admit, Recovery Support and Other. These LOCs may be included in EDW reports, thus resulting in potential discrepancies when comparing numbers. Finally, we do not include data that has been submitted to the agency from programs that are not funded by DMHAS Human Service Agreements.

### **SFY24 Episode Counts**




In SFY 2024, DMHAS-funded and DMHAS-operated programs had:

### **Admissions by Type of Provider**











### Age



During FY24, the mean client age was 44.1(±15) years.

Clients in Substance Use programs tend to be somewhat younger (mean age: 42.0 years) while in Mental Health programs, they tend to be somewhat older (mean age: 45.8 years).

### Race




## **Ethnicity**

In SFY24, the DMHAS population was 21% Hispanic/Latino origin.

While almost half (47%) of the Hispanic respondents are Puerto Rican, many have ties to Central and South America, Mexico, and Cuba.



### **Mental Health Clients by Level of Care**








### **Bed Utilization**




#### Mental Health Beds




### **Primary Substance of Choice at Admission**

Over 65.000 admission records contained information about substance(s) of choice; the primary substance frequencies are charted below. Alcohol was the most common primary substance of choice at admission in SFY24, as it has been since SFY21.



<sup>\*</sup>This category includes benzodiazepines, PCP, amphetamines, hallucinogens, non-prescription methadone, other sedatives or hypnotics, barbiturates, inhalants, methamphetamines, other stimulants, tobacco, tranquilizers, and over the counter medications.

### **Diagnosis**



Diagnosis data come from treatment related programs, and reflect the *most recent primary diagnosis* during the *most recent episode of care* that was open during the fiscal year. "Primary diagnosis" refers to the most concerning problem for which a person seeks help. Note that clients may have more than one primary diagnosis, and many people have more than one diagnosis.

These values represent an unduplicated client count within each diagnostic category. The bar chart above represents over 99% of the diagnostic data; a detailed table may be found in the Appendix.

## Serious Mental Illness (SMI) Prevalence

"Serious Mental Illness" refers to mental, behavioral, or emotional disorders that significantly interfere with one or more major life activities.\*

More than half of all clients qualify for an SMI diagnosis.

### **Substance Use and Co-Occurring Disorder Prevalence**

More than half of all clients served have a substance use disorder.

This statistic is based on both primary and nonprimary diagnoses from the most recent treatment episode.



"Co-Occurring Disorder" refers to the condition of having co-existing mental illness and substance use disorders.†





### **DMHAS Clients Served by Town**

Most DMHAS clients reside in urban areas. This map shows the DMHAS population by volume; higher counts are shown in darker shading.



DMHAS penetration rates were calculated as number of clients per 1,000 residents\*. When mapped, this reveals a more complex picture. Note that two of the darkest towns - Canaan and Windham - are in rural areas. Clusters of towns appear - particularly in the eastern and western parts of the state where population density is lower.
