Block Grant updates

FFY25 President's Budget:

- Includes flat funding for the SUBG (\$2 billion)
 - However, House is proposing increase of \$500 million
 - Proposes new 10% set-aside for Recovery Support Services
- Includes increase of \$35 million for MHBG (\$1.04 billion)
 - House proposing \$15 million increase
 - Does not include set-aside for Prevention and Early Intervention proposed by SAMHSA
