\*Proposed <u>SB-45</u> AN ACT ADDING OPIOID USE DISORDER AND WITHDRAWAL AS A DEBILITATING MEDICAL CONDITION FOR THE PALLIATIVE USE OF MARIJUANA.

\*Proposed <u>HB-5145</u> AN ACT CONCERNING A STUDY OF REGIONAL BEHAVIORAL HEALTH ACTION ORGANIZATIONS.
