House and Senate Special Session

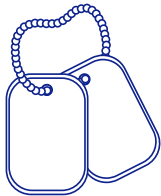
This week, the House and Senate convened for a special session to vote on two emergency certifications. [HB 7066](#) and [HB 7067](#) focused on a number of items including:



Appropriation of \$40 million in supplemental special education funding for local school districts



Appropriation of \$2.8 million to various nonprofit organizations being impacted by loss of federal funding or policy changes from the federal government



Modification of property-tax exemptions for veterans who have a service-connected disability rating of 100%



Allowing colleges and universities to pay their student athletes directly



Prohibition for state agencies and other entities from purchasing/operating drones made or assembled for certain foreign entities and regulating changes on the use of drones

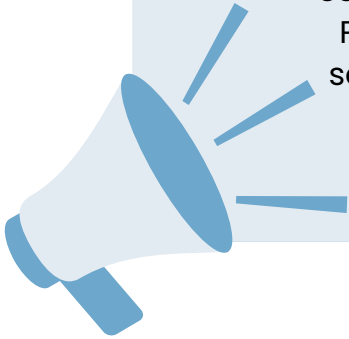


Creation of a new Emergency Certificate of Need process

Did You Know?

There is a way for a bill to reach the floor of the House and Senate without going through the committee process?

These are otherwise known as an **emergency certification**. The Speaker of the House and the Senate President Pro Tempore can jointly propose a bill and send it directly to the House or Senate floor for action. This can take place when the legislative session is underway or during a special session.



Appropriations Human Services Subcommittee State Agency Budget Presentations

More state agencies went in front of the Appropriations Committee [this week](#) to answer questions legislators have pertaining to the Governor's budget. The Department of Social Services, Department of Aging and Disability, and Department of Children and Families fall under the Human Services Subcommittee.

Transportation Committee Public Hearing

The Transportation Committee held a public hearing on February 26th. Some of the bills on the agenda included the Department of Transportation's agency bills. DMHAS submitted testimony in support of Section 5 of [SB 1375](#), which prohibits open alcoholic beverage containers in motor vehicles and Sections 1 through 9 of [SB 1376](#), which looks to reduce blood alcohol limits for impaired driving.
