

Non-compliant Inspection Results January and February 2008

The Department of Mental Health & Addiction Services, Tobacco Prevention & Enforcement Program (TPEP) conducts tobacco compliance checks as part of its efforts to stop the illegal sale of tobacco products to youth the age of 18. The results of non-compliant inspections are forwarded to the Department of Revenue Services for administrative action in accordance with Connecticut General Statute §12-295a. Fines range from first time offense of \$300 for over the counter locations and \$500 for vending machine locations to the possible suspension or revocation of tobacco license.
