

Non-compliant Inspection Results June 2013

The Department of Mental Health & Addiction Services, Tobacco Prevention & Enforcement Program (TPEP) conducts tobacco compliance checks as part of its efforts to stop the illegal sale of tobacco products to youth under the age of 18. The results of non-compliant inspections are forwarded to the Department of Revenue Services for administrative action in accordance with Connecticut General Statute §12-295a. Fines range from first time offense of \$300 for over the counter locations and \$500 for vending machine locations to the possible suspension or revocation of tobacco license.
