Middletown's opioid settlement funds are managed by the Middletown Health Department. Approximately \$409,020.60 has been received thus far, and a total of \$904,946.60 in funding is expected.

The Greater Middletown Opioid Task Force was founded to help people affected by opioid use. From this task force, the Middletown Opioid Settlement Funds Ad Hoc Subcommittee was created to develop a fair and transparent process for funding spending decisions. A community needs survey was shared to better understand Middletown's needs and barriers to access supportive services and help guide opioid settlement spending. The survey highlighted the need for additional Harm Reduction and Recovery Resources and supports, training and education, and awareness of resources.

The task force approved to disseminate naloxone leave behind kits and fentanyl test kits. Additionally, a grant application and review process was developed to offer community grants to organizations providing services to Middletown residents. The proposals were scored by a review team and recommendations from the review team were brought to Common Council and unanimously approved. Another round of grants is anticipated in the future. The approved projects are:

- \$50,000 to employ a Recovery Coach at the Ministerial Health Fellowship
- \$50,000 for the Middletown Prevention Council to conduct media advertising targeting ages 12-21 and community drug disposal
- \$49,528 for Community Health Center of Middletown to operate their Mobile Health Unit Ix per week
- \$25,000 for the Middletown Harm Reduction Initiative to expand their harm reduction activities

-----STATE SETTLEMENT ALLOCATIONS------

This publication will share information on state opioid spending so municipalities can identify the gaps and needs of their area to make an informed decision on municipal spending. In CT, 85% of settlement proceeds are managed by the state, while the municipalities independently manage 15% of the funding. The Opioid Settlement Advisory Committee (OSAC) was established to ensure the proceeds received by the state are allocated appropriately. Received Opioid Remediation Recommendations are vetted by content area experts, followed by a vote by OSAC members to approve the recommendations. DMHAS works in partnership with the other state agencies on the implementation of the approved recommendations. Thus far, OSAC has approved 19 recommendations for statewide implementation.
