Data Review	Susan Logan reviewed DPH data, reviewed monthly report based on confirmed fatal drug overdose cases from 2019- 1st week of March 2023. Committee had inquired about the number of overdoses changing and Susan indicated that data is still being gathered at this time there are no pending cases but sometimes data takes a while to code for cause of death, anticipated that by the end of June DPH should have more recent full year for 2022 data. Susan explained that current data being reviewed is the first six months of data and uncertain on how much it will change, Susan also reviewed data regarding ED visits and suspected opioid overdoses, and explained it is looking at non-fatal data, provided detail to the committee on algorithms built in to the system to look at suspected opiate overdoses, suspected heroin overdoses, suspected stimulant overdoses which would include cocaine and methamphetamines. Susan also provided brief overview of the work DPH has done with local health districts and reviewed maps and compared data for 2021 and 2022 regarding ED visits for suspected opioid overdoses by resident local health department/district. Lisa Deane inquired about the initial report capturing black and brown populations affected by poisoning and overdoses. Susan provided clarification that the report was by year and that DPH has seen that population grow over time and the rates have increased. Susan indicated that a few years ago it was mainly White, not Hispanic individuals, now seeing Black and Hispanic individuals increasing. Lisa inquired about doing monthly reporting of those numbers especially those individuals in the Black and Brown community. Susan was able to confirm this is done with the monthly report Susan also provided information to committee on CT DPH and informed of additional information that could be found on the website. Susan also shared the interactive dashboard where information can be viewed regarding the highest rates by month, race, ethnicity, and what types of drugs used.	Informational

	Dr. Muvvala made comment regarding the data and heroin use, noted it seemed much lower and shows how other drugs causing overdoses like cocaine use and stimulants and polydrug use. Made note that we are seeing fentanyl mixed with everything- it would be good to look at this data and compare it with what kind of overdoses are happening with specific populations. Susan informed the committee that if there was specific information that this group needed DPH could try and provide data. Luiza provided some information to the group regarding DCP and link to review prescription data, pharmacy scripts for naloxone have gone up and provided data that the state has regarding the number of naloxone being distributed in 2022, DMHAS distributed 30,000 kits, in 2021 that number was about 14,000. Committee in agreement useful data to review and will assist committee with decisions moving forward.

Data Review	Susan Logan gave overview of fatal and non-fatal opioid- and stimulant-involved drug overdoses, Connecticut, 2019-2022 data, discussed series of graphs broken out by year, demographic information such as race, ethnicity, age group, pertaining to fatal cocaine plus other substance overdoses. Also reviewed data related to overdoses in major cities, which identified New London having a higher number of fentanyl related overdoses in 2021. Dr. Muvvala, spoke to committee regarding focusing on treatment of opioid use disorders, increasing naloxone supplies, and pointed out that the data was showing overdose death rates in the African American population with cocaine use and cocaine mixed with fentanyl was high and these numbers might be suggesting this population might not be the population normally given methadone and buprenorphine. Suggesting that the committee look into recommendations or strategies to reduce cocaine use in these populations. Suggested recommendations focused on education, uncertain how much awareness there is for those using cocaine mixed with fentanyl, emphasized a focus on contingency management, and harm reduction strategies. 	Ebony sought clarification with the data and what type of cocaine was being referred to, and Susan responded that all cocaine substances are included in the data reviewed and mentioned that much of the cocaine is mixed with fentanyl.	
	Katie- reviewed update on other subcommittees, discussed and reviewed the process and referral recommendation form.	
	Luiza questioned group regarding how much time they thought it would take to review a recommendation. Discussed moving the recommendation along and having the committee identify immediate need recommendations, i.e., harm reduction supplies, naloxone, contingency management as we know these are helpful and an EBP.	
	Ebony agreed to have efficient process and possibly adopt something where a discussion can be made and not have to meet, using different methods to communicate will help be efficient and move things along and not wait 30 days for a meeting.	
	Kennard: Suggested putting together a goal list, starting with naloxone we know this is an immediate need-suggested maybe ten (10) things that are priorities, and the group could work on at next meeting. Committee agreed.	
	Dr. Muvvala- asked if the committee expects to receive recommendations before the next OSAC meeting, Katie discussed the process needs approval and will be presented for a vote at the July 11 th meeting, along with the public participation guidelines. Also informed group the portal is not open yet and will be advertised once that opens so public input can be received.

	Dr. Muvvala: For example, strengthening rural areas for prescribers, primary care physicians and APRN's who are practicing in rural areas to be able to provide treatment for alcohol or opioids is very important. The reason it's important is because individuals from the rural areas, are relocating to big cities to get methadone and this is increasing the populations in these areas, it would be beneficial to treat the individuals where they are at.

	Susan Logan reviewed data; drug overdose deaths pertaining to-education and demographics 2019-2022 and data regarding occupation 2019-2022 reported on the death certificate. Susan reviewed data pertaining to overdose decedent data and homelessness, reviewed data by grade level and other social determinants of health.	
	Dr. Muvvala: Commented that this is important data for the committee to review, as we look at proposals, it will be important to see that there is focus on education status and if we see that folks without a college degree or have dropped out of school earlier, there is a higher risk of overdose compared to others.	
	Susan reported that 3 to 4% or people who died by an overdose are homeless, and suggested looking at the comparison to overall homelessness for all people who die, then break that down further by race and ethnicity

	and gender. Susan then reviewed educational level by gender, race and ethnicity and compared to the total number of people that die over the last four years broken out by gender, race, ethnicity, and reminded the committee this is collected by death certificate information.	
	Pareesa: if you were to calculate percentages or rates, it'd be difficult to tell if there's any disparities by using just the total number, because obviously there's a lot more white people than black people.	
	Pareesa: commented that looking at every race/ ethnicity would be helpful. For example, in CT, would you recommend population at large, or would there be another denominator that would be better, a subcategory that could get better data so that we could have a comparability analysis.	
	Susan commented that it could be done by population at large, or by all decedents, or population rate, probably best to use death certificate data to get those rates as a denominator.	
	Committee suggested looking at all decedents and black males who had died by overdose over the population of males, looking at all races/ethnicities who died by overdose compared to the overall population of males.	
	Lisa commented that the committee will see overdoses are affecting our black and brown communities disproportionately.	
	Susan: When I look at the educational level among all, I looked at all decedents versus overdose decedents and then compare the two. I did not do that for males and females and other demographics, I'd like to go back and create that.	
	Susan reviewed data on occupation discussed reviewing more data at next meeting regarding % of male and female by race either by overall decedents or by occupations.	
	Ebony: I'd like to review data around different zip codes that have the harm reduction programs, and learn more about it, but I wanted to know if we had any numbers about how effective it is, in certain communities because, if we have high rates of overdose in a community but we have harm reduction, Is there any association between harm reduction, and less harm? can we see some sort of numbers behind that?	
	Luiza: there are a lot of harm reduction, treatment, prevention recovery supports programs that have been initiated since 2016 or so, and as the crisis continued to worsen services amped up. Its hard to say what it would look like without these services. Some centers have markers for actual data.

	Dr. Muvvala: it's difficult to compare, for example, if there were no harm reduction initiatives happening in a particular area 10 years ago versus now, because 10 years ago there was no fentanyl at that time, and there was no xylazine.	
	Luiza: data that is captured in other countries, indicates less infections, more public health in general in the area, a cleaner environment, they're typically good neighbors etc.	
	Lisa: discussed safe injection sites and concerns related to individuals served at those sites and verbalized not seeing the benefit. Discussed getting more clean needles and Narcan out on the streets.	
	Luiza: clarified that this committee is not talking about safe injections sites because those are not legal, and talking about harm reduction, contracting and the state will not contract for things that are not federally qualified.	
	Dr. Muvvala: when we talk about harm reduction, we are talking about risk mitigation, needle exchange, syringe, exchange, education, Narcan, fentanyl test strips, xylazine test strips, giving supplies to keep folks safe.	
	Dr. Muvvala reviewed the CORE report and recommended strategies. Encouraged the committee to review the draft report and reminded about the public comment link, and the opportunity to discuss next meeting.
