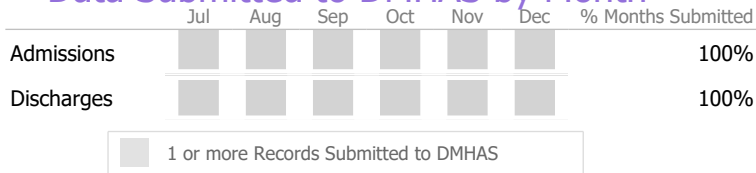

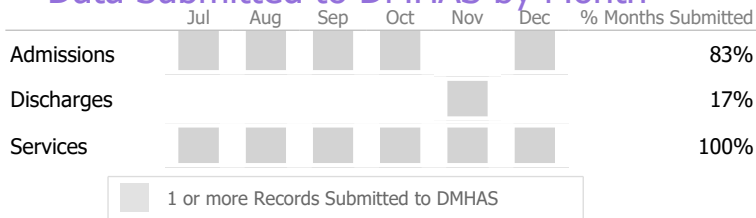

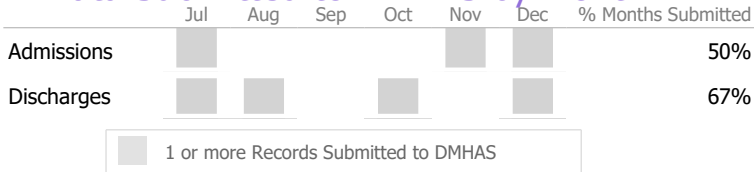

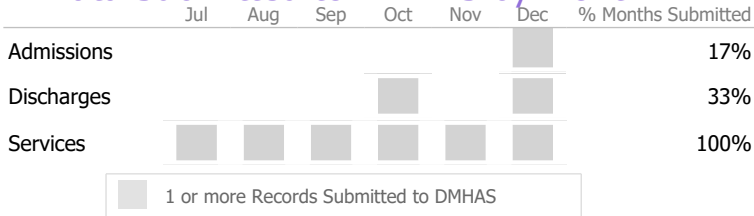

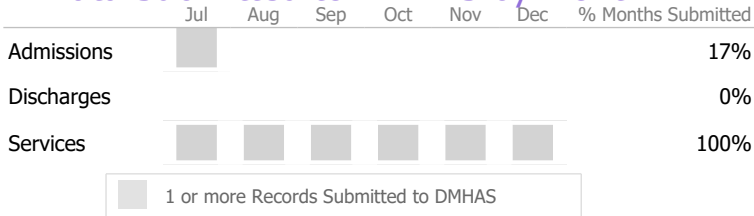

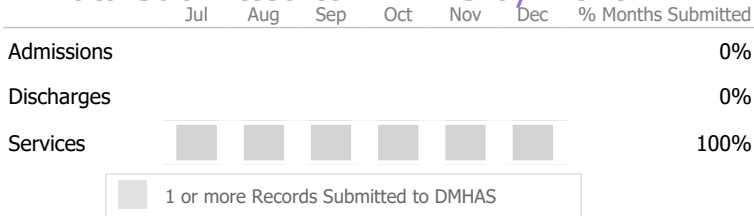

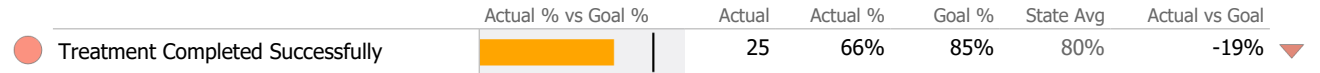

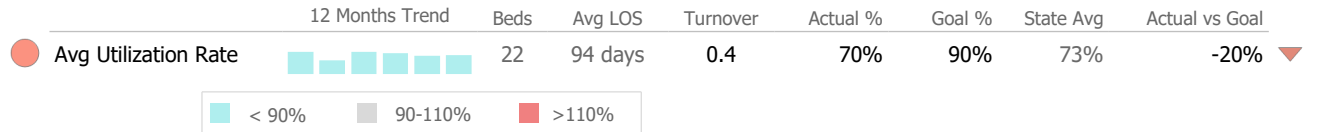

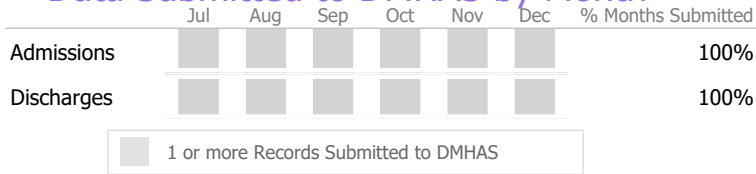
Discharge Outcomes

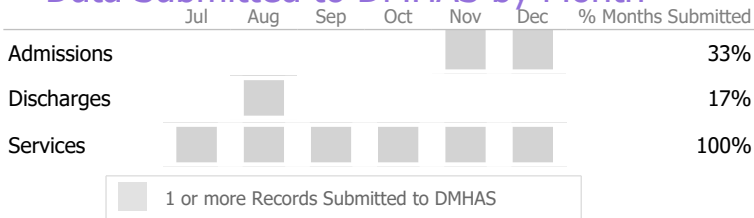
