# DEPARTMENT OF THE ARMY/STATE OF CONNECTICUT 2011 CT GENERAL PERMIT, EFFECTIVE JULY 15, 2011 STANDARD AQUACULTURE TERMS AND CONDITIONS

1. Aquaculture activities under this general permit, as identified within Appendix 2, Section F, are subject to the General Permit Conditions and Requirements of the May 31, 2011, <u>Connecticut</u> <u>General Permit</u>.

2. The project proponent must receive all applicable local and state authorizations for shellfish and aquaculture related activities from Connecticut Department of Agriculture, Bureau of Aquaculture (CT DA/BA) and the Connecticut Department of Energy & Environmental Protection (CT DEEP), including a CT DA/BA lease and/or license in accordance with Connecticut General Statutes (CGS) §22 -11h; register, if required, with CT DEEP Office of Long Island Sound Programs (OLISP) under the *General Permit for Minor Aquaculture Activities and/or General Permit for Placement of Cultch*; and be in receipt of a *Permit for Regulatory Markers* from CT DEEP Boating Division, if one is required.

3. Before the authorized structures are installed the project proponent **must** submit a permit application and receive authorization for <u>Regulatory Markers</u> from the CT DEEP Boating Division, Navigation Safety/Boating Access Unit, P.O. Box 280, 333 Ferry Road, Old Lyme, CT 06371-0280. The permittee shall install and maintain lights, markings and other features as the CT DEEP/ USCG requires. (Note: Documentation of this coordination will be necessary for existing operations that seek reconfigurations and/or new approvals for structures from the Department of Army and for authorizations from the CT DA/BA.)

4. Gear may not be located over or within beds of submerged aquatic vegetation (SAV) such as eelgrass or turtle grass, and coastal wetlands (salt marsh), nor shall such beds or vegetated marsh areas be damaged or removed. Routine lease activity, including cage maintenance, washing, etc., shall not occur within 25 feet of the edge of beds of SAV.

5. All gear shall be designed and deployed in such a manner as to limit, to the greatest extent practicable, negative impacts on avian resources, such as, but not limited to, shore birds, wading birds, or members of the waterfowl group. This is meant to include nesting, feeding, or resting activities by migratory birds identified at 50 CFR 10.13.

6. Installation of structures, their mooring tackle and lines, and any attendant vessels shall not create a hazard or interfere with existing navigation uses in the waterway, and structures shall be set back from the Federal Navigation Project (FNP) a distance of at least 200 feet.

7. The right of the public to traverse or utilize the waters not physically occupied by authorized structures and/or moored vessels within the areal limits of the authorized gear perimeter shall not be impeded.

8. The placement of cultch shall occur only in appropriate locations for working the bed bottom and colonization by oysters, based upon factors of salinity, water quality, water circulation patterns, and substrate composition, and such placement shall not create or exacerbate adverse impact to any aquatic resource (finfish, shellfish, marine mammals, coastal birds), water quality, Essential Fish Habitat<sup>1</sup> or Special Aquatic Sites<sup>2</sup>.

9. New applications of cultch and spatted-shell for the purposes of enhancement or restoration of a native shellfish population and for bottom cultivation associated with commercial shellfish aquaculture on leased grounds cannot be placed within SAV and is limited to the minimum amount necessary for coverage of the target area.

10. The permittee shall be responsible to remove all gear and associated equipment within any leased or designated shellfish area in the event that the operator surrenders or loses the right to its use.<sup>3</sup>

11. The subject aquaculture activity shall not discernibly interfere with natural sedimentation and erosion processes.

<sup>1</sup> Essential Fish Habitat: Those waters and substrate necessary to fish for spawning, breeding, feeding, and growth to maturity.

<sup>2</sup> Special Aquatic Sites: Include Wetlands (inland and salt marsh), intertidal mud flats, vegetated shallow (permanently inundated areas that support rooted aquatic vegetation such as eelgrass, celery grass, and tapegrass), and coral reefs. Per \$) CFR Part 230 Subpart E.

<sup>3</sup> In some situations, a performance bond may be required.



# CT DEPT OF AG LEGISLATIVE REPORT: 2011 SESSION

H.B. 5508 – AN ACT CONCERNING THE GOVERNOR'S COUNCIL FOR AGRICULTURAL DEVELOPMENT PA 11-189, signed 7/13/11, effective date: 10/1/11

This bill reshapes the Governor's Council for Agricultural Development. It establishes the membership at 15 rather than 30 members and specifies members' qualifications.

By law, the council advises the Department of Agriculture on the development, diversification, and promotion of agricultural products, programs, and enterprises, and provides for an exchange of ideas among the commodity groups and organizations it represents.

The bill requires the council to recommend to the Department of Agriculture ways to increase the percentage of consumer dollars spent on Connecticut Grown fresh produce and other farm products. The recommendations must include ways to increase, by 2020, the amount Connecticut residents spend on locally grown farm products to at least 5% of all money spent on food.

The bill sets the council's membership at 15 members instead of permitting up to 30 members. The bill requires, instead of allows, the governor to fill any vacancy in membership.

Under the bill, the members include the following

- 1. The commissioner of agriculture, who serves as chairperson, as under current law;
- The dean of the College of Agriculture and Natural Resources at UConn or the dean's designee;
- Connecticut Milk Promotion Board's chairperson or the chairperson's designee.

Members also include 12 appointees as follows:

- Six members appointed by the governor who are actively engaged in agricultural production;
- One member appointed by the House speaker who engages in agricultural processing;
- One member appointed by the president pro tempore of the Senate who engages in agricultural marketing;
- One member appointed by the House majority leader who engages in agricultural sales;
- One member appointed by the Senate majority leader from a trade association;
- One member appointed by the House minority leader from the green industry;
- One member appointed by the Senate minority leader who is actively engaged in agricultural education.

By law, the council must meet at least once each calendar quarter. A member who is absent from more than two meetings per year is deemed to have resigned. Members serve without compensation or reimbursement for expenses.

# **ORGANIC COST-SHARE PROGRAM**

The Connecticut Department of Agriculture and the USDA National Organic Program (NOP) have entered into a cooperative agreement for the Organic Cost Share Program.

By offering reimbursement for certification-related expenses, the NOP recognizes the cost of regulation and makes certification more affordable to farmers.

Connecticut organic producers and handlers can be reimbursed for a portion of their certification fee. Reimbursement will be 75% (up to \$750) of the certification cost. This year's approved cooperative agreement allows a maximum total of \$37,000 for producers and \$5,000 for handlers. This program is administered on a first-come, first-served basis until funds are exhausted.

To apply, producers/handlers must provide the Connecticut Department of Agriculture with a copy of their 2011 certification certificate from an accredited certifier and a certification financial form (bill of cost for certification).
