NOTES from the **DEPARTMENT**...

DAIRY SUSTAINABILITY GRANT PROGRAM

In fiscal year 2010-11 (July 2010 through June 2011) the Connecticut Department of Agriculture distributed \$4,848,017 to 134 Connecticut milk producers in the form of Dairy Sustainability Grants. During this period, Connecticut milk producers received an effective average statistical uniform milk price of approximately \$19.88/cwt. or \$1.70 per gallon of milk produced.

The grant formula is prescribed by statute and uses 82 percent of the cost of production for a New England state, as published by the United States Department of Agriculture (USDA) Economic Research Service, to establish the "minimum sustainable monthly cost of production." The department had been using USDA's estimated cost of production published for the state of Vermont until USDA stopped publishing those numbers. The grant payment is equal to the difference between the minimum sustainable monthly cost of production and the "federal pay price" (Northeast Federal Milk Marketing Order, statistical uniform price for the Hartford zone) multiplied by your monthly production.

Because USDA stopped producing dairy cost-of-production statistics, the department entered into a memorandum of understanding with the University of Connecticut's Charles J. Zwick Center for Food and Resource Policy. Under the MOU, Dr. Lopez is providing the department with cost of production figures using the USDA model. Long term, the department will seek to have cost of production based on conditions specific to Connecticut.

Since June 2011, the statistical uniform milk price has been high enough so that no payments were triggered. No payments are expected until the statistical uniform milk price goes below approximately \$20.00/cwt or the cost of production rises to a level that will trigger a payment or some combination of both.

TROPICAL STORM IRENE

Tropical Storm Irene and the remnants of Tropical Storm Lee caused considerable damage to vegetable crops and some damage to forages. Damage in Vermont and parts of New York have been

catastrophic. Much of the field corn here in Connecticut will have been harvested by the time this article is published. Overall the damage to forages here in the state has been hard to quantify. Some fields are obviously severely damaged; in many cases the damage is less noticeable but will be show itself in poorer quality feed.

The state of Vermont is engaged in a mitigation effort for flooded forages that may pose a hazard due to toxic molds. While we do not believe we will have a significant issue with mold here in Connecticut, producers should be aware of the conditions that promote mold formation, the effects toxic molds may have, and mitigation strategies. In addition, it is very important that you report damage to your local <u>USDA Farm Service Agency office</u> within 30 days of the loss in order to qualify for any programs that may be offered through FSA, and contact your crop insurance agent, if applicable.





WHIP helps people who want to develop and improve wildlife habitat on private lands. NRCS provides technical and financial assistance on forest land, grassland, riparian areas, state-identified imperiled habitats, old fields, streams and rivers, early successional wetlands (tidal and non-tidal), and shallow and deep water habitats.
