STATE APPROVES \$5,000,000 BONDING TO PURCHASE DEVELOPMENT RIGHTS TO CONNECTICUT FARMLAND

On August 26, 2011, Governor Dannel P. Malloy and Agriculture Commissioner Steven K. Reviczky announced that \$5,000,000 in state bonding was approved by the State Bond Commission for the purchase of development rights to farmland statewide.

The allocation of funds for the state's Farmland Preservation Program, which is administered by the Department of Agriculture, will be used to buy development rights to farms, placing a permanent restriction on the use of the land. The land can only be used for agricultural purposes and the farms will stay under private ownership and continue to pay local property taxes.

"Agriculture contributes \$3.5 billion in output and 20,000 jobs to our economy each year," Commissioner Reviczky said. "This program will help keep our wonderful farms and farm communities viable. It also ensures we retain the ability to produce food, create jobs, and preserve the unique character of our state. Farms are integral to the high quality of life we enjoy in Connecticut."

The goal of the program is to preserve 130,000 acres of farmland with 85,000 acres dedicated to growing crops. The state preserved its first farm in 1979. Since then, 37,860 acres have been preserved, or approved for preservation, on 287 farms or about 29% of its goal. The new funds are expected to allow the state to buy development rights to at least 10 more farms comprising 1,100 acres over the next several months.

The CT Farmland Preservation Program protects farmland through the negotiation of an acquisition of development rights to qualified farms. Farm owners apply to the program voluntarily. A permanent conservation easement is recorded on land records indicating the farm is restricted to agricultural use only, preventing residential development and subdivision. Protected farms help Connecticut retain its rural character and scenic vistas, protect natural resources, promote local food security, and sustain employment in the agricultural sector.

The RFP consists of a competitive solicitation covering PV only and a rolling submission solicitation to help fund all other Connecticut Class I renewable energy generating equipment.

The competitive, PV-only solicitation offers grants to buy down the cost of installing new PV renewable energy generating equipment at commercial, industrial and institutional facilities in Connecticut. REPORT STORM DAMAGE TO DOAG AND FSA

The Connecticut Department of Agriculture is collecting information about storm-related damage to farms in the state. This information will be used to prepare reports for Governor Malloy, and the Department of Emergency Services and Public Protection, if needed, and may be used to seek federal assistance if the extent of the damage warrants. If you incurred damage to your livestock, crops, equipment, or buildings, please complete and return the damage report form on DoAG's website, www.ct.gov/doag.

In addition, it is very important that you report damage to your local <u>USDA Farm Service Agency office</u> within 30 days of the loss in order to qualify for any programs that may be offered through FSA, and contact your crop insurance agent, if applicable.
