# **DOAG 2012 LEGISLATIVE UPDATE**

HB 5326, AN ACT ENCOURAGING THE PURCHASE OF FOOD

PRODUCTS GROWN OR MADE IN CONNECTICUT, effective
upon passage.

There is established a task force to examine and investigate methods and incentives to encourage consumers to purchase food products that have traceable points of origin in the state of Connecticut. The task force shall consist of the following members:

- (1) One appointed by the speaker of the House of Representatives;
- (2) One appointed by the president pro tempore of the Senate;
- (3) One appointed by the majority leader of the House of Representatives;
- (4) One appointed by the majority leader of the Senate;
- (5) One appointed by the minority leader of the House of Representatives;
- (6) One appointed by the minority leader of the Senate;
- (7) One appointed by the governor;
- (8) The commissioner of Agriculture, or the commissioner's designee;
- (9) The commissioner of Economic and Community Development, or the commissioner's designee;
- (10) A representative of the Connecticut Food Association, who shall be appointed by speaker of the House of Representatives; and
- (11) A representative of the Connecticut Food Policy Council, who shall be appointed by the president pro tempore of the Senate

Any member of the task force appointed under subdivision (1), (2), (3), (4), (5) or (6) of subsection (b) of this section may be a member of the General Assembly.

All appointments to the task force shall be made not later than thirty days after the effective date of this section. Any vacancy shall be filled by the appointing authority.

The speaker of the House of Representatives and the president pro tempore of the Senate shall select the chairpersons of the task force, from among the members of the task force. Such chairpersons shall schedule the first meeting of the task force, which shall be held not later than sixty days after the effective date of this section. The administrative staff of the joint standing committees of the General Assembly having cognizance of matters relating to the Department of Agriculture and the Department of Consumer Protection shall serve as administrative staff of the task force.

Not later than January 1, 2013, the task force shall submit a report on its findings and recommendations to the joint standing committees of the General Assembly having cognizance of matters relating to the Department of Agriculture and the Department of Consumer Protection, in accordance with the provisions of section 11-4a of the general statutes. The task force shall terminate on the date that it submits such report or January 1, 2013, whichever is later.

H.B. 5258, AN ACT PERMITTING THE POSSESSION OF REIN-DEER YEAR ROUND, effective July 1, 2012.

This bill requires the agriculture commissioner, by September 1, 2013, to adopt regulations in consultation and agreement with the energy and environmental protection (DEEP) commissioner, to allow in-state captive herds of cervids (i.e. deer), including reindeer. The bill requires the agriculture commissioner, by November 1, 2012, to implement a pilot program under which he issues two permits that allow up to two Connecticut businesses to have up to five reindeer each. Each reindeer must have an importation permit issued by the agriculture commissioner in consultation with the DEEP commissioner. The importation permits must be on forms the agriculture commissioner provides and are contingent on requirements he determines, including the source of the reindeer, any required health certification, fencing and containment requirements, periodic inspections, and testing.



The pilot program remains in effect until regulations are adopted. Current law allows anyone to import reindeer into the state between Thanksgiving Day and New Year's Day if they are (1) individually identified, (2) certified to be in good health, and (3) exported from the state by January 8. The bill specifies that current law remains in place until regulations are adopted.

#### REGULATIONS

The required regulations must include standards and procedures for protecting native wildlife and provisions for:

- issuing permits for importing, exporting, and maintaining captive herds;
- seasonal interstate transport and possession of reindeer pursuant to the pilot program (but the pilot program ends when the regulations are adopted) until domestic herds are sufficiently established to meet demand; and
- inspections and enforcements. The bill requires that any importation permit be issued by the agriculture commissioner in consultation with the DEEP commissioner.

s.H.B. 5263, AN ACT INCREASING THE PENALTY FOR POACH-ING, effective October 1, 2012.

By law, a person who enters or remains in any premises to hunt, trap, or fish, although the person knows he or she is not licensed or privileged to do so, is guilty of 3rd degree criminal trespass. This bill increases the penalty for this offense, making it a Class B misdemeanor punishable by up to six months imprisonment, a fine of between \$500 and \$1,000, or both. Under current law, it is a Class C misdemeanor punishable by up to three months imprisonment, up to a \$500 fine, or both.

s.H.B. 5447, AN ACT CONCERNING AQUATIC ANIMALS AS FOOD AND THE TAKING OF SCALLOPS FROM THE NIANTIC RIVER, effective July 1, 2012, except for the provision requiring the agriculture commissioner to adopt regulations, which is effective October 1, 2012.

This bill requires the agriculture commissioner to adopt regulations for licensing and inspecting aquaculture facilities that cultivate, process, and supply aquatic animals for human consumption. The bill increases, from 2 to 2-1/2 inches, the minimum size of scallops that a person can take from the Niantic River. It allows the Waterford-East Lyme Shellfish Commission to increase or decrease the daily limit of scallops a person can take, rather than just increase it. The bill also makes technical changes.

# REGULATIONS REGARDING AQUACULTURE FACILITIES

The bill requires the commissioner's regulations to promote compliance with principles, practices, and generally recognized standards that protect public health. The regulations must include:

- (a) minimum qualifications for aquaculture facilities and
   (b) license application and renewal procedures;
- processing and inspection standards for aquaculture facilities, including compliance with federal law;
- designating compliant facilities as an "approved food source" for households, restaurants, hotels, and other residential facilities; and
- 4. the commissioner's oversight of aquaculture facilities.

Under the bill, "aquaculture" is the controlled rearing, cultivating, and harvesting of aquatic animals in land- or marine-based culture systems, tanks, containers, impoundments, floating or submerged nets or pens, and ponds. "Aquatic animals" are fresh or saltwater finfish, crustaceans, and other aquatic life forms, including alligator, frog, turtle, jellyfish, sea cucumber, sea urchins, their roe, and mollusks, that are intended for human consumption.

#### NIANTIC RIVER SCALLOPS

By law, the Waterford-East Lyme Shellfish Commission may regulate the taking of scallops, clams, and oysters from the Niantic River. Current law prohibits taking (1) any scallop that passes through a 2-inch ring, or (2) more than three bushels of scallops a day. But the commission may increase the daily limit after it has been in place for 30 days. The bill instead prohibits taking any scallop that passes through a 2-1/2-inch ring, thereby increasing the minimum size of scallops that a person may take. It maintains the three-bushel limit, but the commission may increase or decrease it after 30 days.

By law, a violator is subject to a fine of up to \$200, imprisonment of up to 10 days, or both. Upon conviction, the court may order that the violator cannot hold a permit or license to take shellfish in the Niantic River until the second season following the conviction.
