CONNECTICUT'S HEALTH INSURANCE EXCHANGE: A RESOURCE FOR FARMERS

More than a third of agricultural workers have no insurance, and their 37% uninsured rate is nearly double the 19% rate for all blue- and white-collar workers, according to an October 2012 report by the Kaiser Commission on Medicaid and the Uninsured.

Lack of insurance not only

affects access to health care, but also can bring serious financial implications since those lacking coverage are more likely to exhaust their savings or go into debt to pay for medical care.

According to the Kaiser Family Foundation, 47.9 million people in the United States under the age of 65 were without health insurance in 2011. The main reason people give as to why they are uninsured is that they cannot afford coverage.

In an effort to decrease the number of people without health insurance, Congress passed the Affordable Care Act (ACA) in 2010. The ACA is designed to improve access to affordable coverage through the following:

- Expanding the existing Medicaid program to include those with lower incomes
- Creating health insurance exchanges and providing premium subsidies for others
- Changing certain policies to establish coverage and benefit standards

The ACA required states to have a health insurance exchange (or marketplace) in place by October 1, 2013. Connecticut was proactive, establishing the Connecticut Health Insurance Exchange as a quasi-public agency in 2011. Directed by a 14-member board, it is chaired by Lieutenant Governor Nancy Wyman.

Connecticut's exchange is now called Access Health CT. If you, your employees, or others you know are uninsured or in need of more affordable coverage, Access Health CT is designed to provide

Below are a number of frequently-asked questions about Access Health CT, along with the answers provided on its website.

WHAT IS ACCESS HEALTH CT?

Access Health CT is Connecticut's official health insurance marketplace. It offers Connecticut residents and small employers a range of qualified health care coverage options from health insurance carriers and public health care programs. You can get the coverage you need online, over the phone or in person.

Access Health CT is also the only place in Connecticut where individuals, families, and small businesses can get financial help with their health care coverage costs, if they qualify.

Access Health CT was established to meet the requirements of the federal Health Care Reform law (or Affordable Care Act), which requires that states have a "health insurance exchange" (or marketplace) in place by October 1, 2013.

CAN ANYONE USE ACCESS HEALTH CT?

Access Health CT is open to all legal residents of Connecticut. To obtain health care coverage through Access Health CT, you must live in Connecticut, be a U.S. citizen or lawfully present, and cannot currently be incarcerated. Access Health CT is for you if:

- a. You need healthcare coverage
- Your employer doesn't insure you or doesn't offer affordable coverage
- c. You're self-employed
- d. You've been denied insurance due to a pre-existing condition
- e. You're insured but looking for cost savings



HOW DO I FIND A PLAN, APPLY, AND ENROLL THROUGH ACCESS HEALTH CT?

There are several convenient ways. You can:

Apply in person through a trained and certified insurance broker or in-person assister – either at an enrollment center or at one of our enrollment fairs throughout Connecticut

Call Access Health CT at 855-805-4325 to talk with a trained specialist who can answer your questions and guide you through the enrollment process – in many different languages.

Use the Access Health CT website to see if you qualify for financial help or certain public health care programs, compare available health plans, and complete a single application that may be used to apply for any plan or program.

WHEN CAN I ENROLL IN ACCESS HEALTH CT?

You can enroll now through March 31, 2014. There will be an annual open enrollment period going forward.

HOW LONG WILL THE ENROLLMENT PROCESS TAKE?

For those individuals or small households that don't require assistance, we estimate that it may take about 30–45 minutes to complete the enrollment process. For larger households, or those with complex situations or eligibility issues, it may take longer.

CAN I REALLY GET COVERAGE IF I HAVE A PRE-EXISTING HEALTH CONDITION?

Yes. Coverage for those with pre-existing conditions was one of the big changes made possible by the federal government's Affordable Care Act. Starting in 2014, you cannot be denied coverage or charged more just because you have a pre-existing health condition. Your cost will be calculated based on your age, family size, geographic location, and the coverage you choose.

HOW DO I KNOW WHETHER I QUALIFY FOR MEDICAID OR A SUBSIDY FOR HEALTH INSURANCE?

It will depend on your household size and income. Thanks to an expansion of Medicaid under the Affordable Care Act, eligibility for Medicaid is expanding in many states, including Connecticut. Some Connecticut residents who are above the Medicaid income level may be eligible for subsidies to help cover their monthly premium payments for a qualified health plan purchased through Access Health CT. If they qualify, they may also be eligible for subsidies to help pay for their out-of-pocket costs for essential health benefits.

When you fill out an application with Access Health CT, you'll learn if you or your children qualify for free or low-cost coverage through Medicaid or the Children's Health Insurance Program (CHIP), or if you qualify for subsidies to pay for health insurance through Access Health CT.

HOW DO SUBSIDIES WORK FOR INDIVIDUALS AND SMALL BUSINESSES?

Individuals who earn up to \$45,960 a year may qualify for tax credits to help cover their monthly health insurance premiums. Families may also be eligible, depending on income and size. For example, a family of four earning up to \$94,200 a year might qualify. Some individuals may also qualify for cost-sharing reductions that lower the amount they pay out of pocket for essential health benefits.

Small businesses that qualify may benefit from subsidies in the form of a tax credit. To qualify, a small business must contribute at least 50 percent of each employee's insurance premium, pay an average annual wage of less than \$50,000, and have fewer than 25 full-time-equivalent (FTE) employees. Eligible businesses can claim this credit for any two consecutive years beginning in 2014.

ARE THERE TAX PENALTIES FOR INDIVIDUALS AND SMALL BUSINESSES THAT DO NOT SIGN UP FOR HEALTH CARE COVERAGE?

As of January 1, 2014, most U.S. residents will be required to have health care coverage, and the federal government has set certain tax penalties (listed on the Access Health CT website) for individuals who do not have coverage.

The law provides exemptions for certain individuals, including those below a certain income and those who are without coverage for fewer than three consecutive months.

If you are a business owner with fewer than 50 full-time-equivalent (FTE) employees, you will not have to pay a penalty if you do not provide insurance to your employees. If you have more than 50 FTE employees and do not provide insurance to your employees, you may be subject to penalties beginning in 2015.
