Connecticut Department of Agriculture Awards Nearly \$350,000 in Farmland Restoration Grant Projects

The Connecticut Department of Agriculture is pleased to announce that 23

main objective is to increase food and fiber production in Connecticut through restoring lands into active agricultural production. The FLRP focuses on restoring and improving land with prime and important farmland soils, in accordance with a Farmland Restoration Program Plan.

“Through the Farmland Restoration Grant Program, we can provide farmers an invaluable tool to reclaim and restore overgrown cropland and improve irrigation and drainage,” said Agriculture Commissioner Bryan P. Hurlburt. “Connecticut’s land base is finite, however, by increasing the amount of usable farmland acreage with a focused priority on human food production, we are positioned to further develop a robust food system capable of meeting the needs of all residents.”

Established in 2011, the FLRP has awarded more than \$4 million in funding to 252 prior applicants. The program assists farmers across the state by helping them to develop farm conservation and resource management plans to restore farmlands and reestablish use of the state’s prime and important agricultural lands.

Grants are awarded with a priority given to food producing agriculture, with human food production considered the highest priority. Whether the farmland has been preserved through an agricultural conservation easement is also considered, and also whether the farmland is state or municipally-owned, or managed by a non-profit organization with an educational mission. Livestock, livestock feed, livestock support production, and other agricultural uses may be considered based on land use, food production, and acreage to be restored.

The FLRP provides an opportunity to enhance the use of agricultural lands that are currently underutilized and helps farmers by providing restoration plans for restoration activities, and by paying up to 50% of the cost, or \$20,000, whichever is less. On state or municipal owned farmland under long-term agricultural leases of five years or more, the total state share may be up to 90% of the restoration costs on such lands up to \$20,000.

All the awarded 2021 FLRP grants are food-producing operations. Of those, 10 are on preserved farmland; four are on state or town-owned farmland; two are non-profit educational or charity organizations; and seven are primarily food-producing operations for gross annual sales greater than \$50,000. Work to be performed includes brush and tree removal; stone and stump removal; irrigation; fencing; land clearing; and well installation.

Heart Farm, Ledyard; Oakledge Farms, Lebanon; Cloverleigh Farm, LLC, Columbia; Shortts Farm, Newtown; Devon Point Farm, Stonington; Urbanowicz Farm, Enfield; and Muddy Roots Farm, Meriden.

**SEEKING CT GROWN PRODUCE FOR USDA-FUNDED FOOD BOXES
(TEFAP)**

Grown produce for TEFAP (The Emergency Food Assistance Program) produce boxes.

The Connecticut Department of Agriculture is working with Aggrigator, a company out of CA, which was awarded a USDA TEFAP contract, to include CT Grown produce in their distribution of food boxes to Connecticut food banks. Aggrigator's contract award for Connecticut includes approximately 12,000 boxes over a 16-week period from June through September.

Boxes are required to contain at least four different types of produce with up to 3 lbs. of root vegetables. Ideally product should be packed in reusable plastic containers (RPC), although bins are also feasible. Product can be #2 quality.

Eligible producers include those that possess the following certification and are also able to meet all USDA audit requirements:

- USDA Good Agricultural Practices/Good Handling Practices certified
- Global Food Safety Initiative (GFSI) certification program audits (GlobalGAP, SQF, Primus GFS)

Producers should contact Aggrigator with their current and future product availability as soon as possible. Food boxes are scheduled to begin shipping around June 1. Co-packing of boxes will be within the region.

USDA TO BEGIN LOAN PAYMENTS TO SOCIALLY DISADVANTAGED BORROWERS UNDER AMERICAN RESCUE PLAN ACT SECTION 1005

The U.S. Department of Agriculture Farm Service Agency (FSA) today published the first notice of funding availability (NOFA) (PDF, 242 KB) announcing loan payments for eligible borrowers with qualifying direct farm loans under the American Rescue Plan Act Section 1005. The official NOFA will be published in the Federal Register early next week and USDA expects payments to begin in early June and continue on a rolling basis. A subsequent notice addressing guaranteed loan balances and direct loans that no longer have collateral and have been previously referred to the Department of Treasury for debt collection for offset, will be published within 120 days.

guaranteed loan outstanding balances as of January 1, 2021, for socially disadvantaged farmers and ranchers as defined in Section 2501(a) of the Food, Agriculture Conservation, and Trade Act of 1990 (7 U.S.C. 2279(a)). Section 2501(a) defines a socially disadvantaged farmer or rancher as a farmer or rancher who is a member of a socially disadvantaged group, which is further defined as a group whose members have been subjected to racial or ethnic prejudice because of their identity as members of a group without regard to their individual qualities. Qualifying loans as part of today's announcement are certain direct loans under the Farm Loan Programs (FLP) and Farm Storage Facility Loan Program (FSFL).

DAIRY MARKETING & BRANDING SERVICES GRANT: RFA RELEASED

On April 27, the application period opened for the Northeast Dairy Business Innovation Center (NE-DBIC)'s Dairy Marketing and Branding Services Grant Program. Funds will be available to established value-added dairy processors across the Northeast region (CT, DE, MA, ME, NH, NJ, NY, PA, RI, and VT).

Grant funds will be used to prioritize grantees hiring professional marketing/branding contractor(s) to develop strategy and/or content for their business. Up to 25% of the grant funds may be used to implement the strategy and/or content developed by the contractor. Projects funded by this grant will increase the exposure and promotion of regionally produced dairy products guided by marketing/branding professionals.

Grants will range from \$10,000 - \$50,000 each with \$400,000 in available funding. Projects will require a 25% cash and/or in-kind match commitment.

USDA GRANTS FOR FOOD PRODUCERS AFFECTED BY THE PANDEMIC

The U.S. Department of Agriculture (USDA) announced the availability of \$92.2 million in competitive grant funding under the 2018 Farm Bill's Local Agriculture Market Program (LAMP). The LAMP grants are funded through the Farmers Market program as part of USDA's Pandemic Assistance for Producers Initiative. USDA launched this initiative in March to address shortfalls and disparities in how assistance was distributed in previous COVID-19 assistance packages, with a specific focus on strengthening outreach to underserved producers and communities and small and medium agricultural operations. These grants support the development, coordination and expansion of direct producer-to-consumer marketing, local and regional food markets and enterprises and value-added agricultural products.

USDA encourages projects that assist underserved local and regional agricultural businesses, producer networks and associations, and local and tribal government in responding to COVID-19 disruptions and impacts. Funding is not contingent upon applicants directly addressing these issues.


