Supporting Connecticut's Farmers and Restaurants During Farm-to-Chef Week

Kick-off event on Saturday, August 28 with celebrity chef Chrissy Tracey

The Connecticut Department of Agriculture (DoAg) announces that 2021 Farm-to-Chef Week will run from Sunday, August 29 through Saturday, September 4. This special week encourages culinary professionals to use Connecticut Grown ingredients in new ways on their menus while educating residents and visitors about the diversity of farm products grown and raised in Connecticut.

"Connecticut's farmers can always be counted on to deliver high quality, fresh food – from oysters in the Long Island Sound and milk year-round to Connecticut Grown fruits, vegetables, maple syrup, and honey. Farm-to-Chef Week celebrates that through the creative vision of Connecticut chefs," said Bryan P. Hurlburt, Agriculture Commissioner. "I encourage Connecticut's residents to visit a participating dining venue, enjoy a delicious meal, and support our local businesses – both farmers and eateries – who have weathered significant challenges but always deliver the best."

"We are really excited to participate in Farm-to-Chef Week again, especially after the challenges of the COVID-19 pandemic," said Eli Hawli, owner of Marketplace Hospitality, which has signed up seven dining venues to participate this year. "This past year has highlighted the importance of local businesses working together. As a chef-driven organization using fresh CT

Chris Pacheco, owner of Seacoast Mushrooms in Stonington, is a Connecticut farmer growing gourmet mushrooms sold at farmers' markets and dozens of restaurants throughout the state. "Collectively, we talk about supporting local farms and Connecticut Grown," he says. "Farm-to-Chef is a very real example of local businesses supporting each other in the community. It happens every day! We work together to produce and prepare food to feed the communities that helped to build our food-focused businesses. I find it inspiring to work with great chefs and restaurateur to ensure consumers have access to fresh, local foods. In my mind, the pandemic put CT GROWN in bold letters. Over the past year CT farms and CT chefs fed a lot of people through open air farmers' markets and chef prepared, ready-to-eat, at-home meals. I would say that our farmer/chef relationship has strengthened this past year — it became very personal for all of us — as we worked together to ensure our local communities were fed."

This year an in-person kick-off will take place on Saturday, August 28 at CitySeed's Wooster Square Farmers' Market at Conte West Hills Middle School in New Haven from 9 am to 1 pm. The event will include chef demonstrations with Christian "Chrissy" Tracey as well as Chef Poreyah of Vegan Ahava.

Tracey is a vegan chef for Bon Appetit Magazine and runs a company called Vegan Vibes Meal Prep in Connecticut. She is a CT 40 Under 40 recipient and contributes her excess resources as a business owner to providing low-income families with plant-based meals in New Haven County. Poreyah is from Southern Judea In Israel and went through CitySeed's Food Business Entrepreneurship program. Tracey and Poreyah will shop the farmers' market and prepare dishes using CT Grown ingredients. In addition to the regular vendors at the market, special guests New England Sea Farms and Bell's Shellfish will be there this week selling kelp and shellfish as well. Understanding the challenges that many restaurants faced over the past year due to COVID-19 and staffing shortages, sponsorships of Farm-to-Chef Week made it possible for a limited number of venues to sign up at no cost. Special thanks to the following organizations for their support of this initiative, including Highland Park Market, Farm Credit East, CT Milk Promotion Board, Bozzuto's, Sardilli, FreshPoint, Skyeline Studios, LLC, and CitySeed.

DoAg launched the Farm-to-Chef Program in 2006 to help connect foodservice professionals with Connecticut Grown farm products. There is no cost to either farmers or chefs to join. Farm-to-Chef Week was started by DoAg in 2010 as part of its year-round Farm-to-Chef Program.



2021 ORGANIC CERTIFICATION COST SHARE GRANT PROGRAM

The Connecticut Department of Agriculture is applying for the National Organic Certification Cost Share Program (NOCCSP) Grant from the USDA Farm Service Agency.

Through this grant, Connecticut certified organic growers and processors can be reimbursed for 50%, up to \$500, for the cost of receiving and maintaining USDA organic certification. A list of certified organic growers and processors is available through USDA's Organic INTEGRITY Database at https://organic.ams.usda.gov/integrity.

The program is administered on a first-come, first-served basis until funds are exhausted. The amount reimbursed will be 50%, up to \$500, of the certification cost paid between October 1, 2020 and September 30, 2021.

USDA TO INVEST \$50 MILLION IN NEW COOPERATIVE AGREEMENTS FOR RACIAL JUSTICE AND EQUITY

The U.S. Department of Agriculture (USDA) is investing up to \$50 million in cooperative agreements to support historically underserved farmers and ranchers with climate-smart agriculture and forestry. The Racial Justice and Equity Conservation Cooperative Agreements are available to entities for two-year projects that expand the delivery of conservation assistance to farmers who are beginning, limited resource, socially disadvantaged, and veteran

"Historically underserved producers face significant barriers in accessing USDA assistance for conservation and climate-smart agriculture," said Thomas L. Morgart, Connecticut State Conservationist for the Natural Resources Conservation Service (NRCS). "USDA is committed to revising programs to be more equitable, and these producers deserve our support as they contribute to our vibrant and diverse agricultural communities."

The projects should help historically underserved farmers and ranchers in implementing natural resources conservation practices that:

- Improve soil health
- Improve water quality
- Provide habitat for local wildlife species of concern
- Improve the environmental and economic performance of working agricultural land
- Build and strengthen local food projects that provide healthy food and economic opportunities

Projects should remove barriers to access and reach historically underserved groups through a combination of program outreach and technical assistance in managing natural resources that address one or more of the following four NRCS priority areas:

- Addressing local natural resource issues
- Using climate-smart agriculture practices and principles
- Encouraging existing and new partnerships
- Developing state and community-led conservation leadership for historically underserved agricultural producers, including educating and training students for careers in natural resources management

Who Is Eligible Entities who provide outreach assistance to historically underserved groups are eligible, including:

- Native American Tribal governments and organizations.
- Nonprofit organizations
- Private and public institutions of higher education

Historically underserved producers include those who are considered beginning, limited resource, socially disadvantaged, and veteran farmers and ranchers.

How to Apply

Applications must be received by 11:59 p.m. Eastern Standard Time on October 25, 2021. See the <u>grants.gov announcement</u> for details and application instructions.

The U.S. Department of Agriculture (USDA) announced the details of the Pandemic Market Volatility Assistance Program as part of meetings with farmers and a tour of farms with Senator Leahy. In June, Secretary Vilsack committed to providing additional pandemic assistance for dairy farmers in an exchange at a hearing with Senate Appropriations Committee Chairman Leahy. Through the program, USDA will provide about \$350 million in pandemic assistance payments to dairy farmers who received a lower value for their products due to market abnormalities caused by the pandemic. The assistance is part of a larger package including permanent improvements to the Dairy Margin Coverage safety net program.

EXPANDED ELIGIBILITY AND EXTENDED DEADLINE FOR GOAT AND SHEEP DAIRY SUPPLY CHAIN GRANT

The NE-DBIC is currently accepting applications from sheep and goat dairy farmers, processors, and industry associations for the Goat & Sheep Dairy Supply Chain Grant. The application is now open to applicants from across the Northeast region: Delaware, New Jersey, New York, and Pennsylvania in addition to New England states. Grant range: \$15,000–\$50,000 with a 25% match commitment. This funding is for projects that accomplish at least one of the following objectives related to goat and/or sheep dairy products:

- Increase consumer awareness
- Develop market channels and distribution opportunities
- Support innovative strategies to increase consumption
- Increase business revenues

USDA ANNOUNCES DAIRY DONATION PROGRAM

U.S. Department of Agriculture (USDA) Deputy Secretary Jewel Bronaugh announced the establishment of a \$400 million Dairy Donation Program (DDP). The DDP, established by USDA's Agricultural Marketing Service (AMS) in accordance with the Consolidated Appropriations Act of 2021, aims to facilitate timely dairy product donations while reducing food waste.

The establishment of DDP is part of \$6 billion of pandemic assistance USDA <u>announced</u> in March and follows last week's announcement of \$350 million Pandemic Market Volatility Assistance Program for dairy farmers on August 19. It is the second part of an over \$2 billion comprehensive package to help the dairy industry recover from the pandemic and improve or establish programs to make it more resilient to future challenges.

Under the DDP, eligible dairy organizations will partner with non-profit feeding organizations that distribute food to individuals and families in need. Those partnerships may apply for and receive reimbursements to cover some expenses related to eligible dairy product donations. DDP was inspired in part by the donations made by Michigan Milk Producers Association in conjunction with the Food Bank of Eastern Michigan in response to the Flint water crisis.

Dairy farmers, cooperatives, or processors that purchase fresh milk or bulk dairy products to process into retail-packaged dairy products and meet other requirements are eligible to participate. Costs reimbursed through the program include the cost of milk used to make the donated eligible dairy product and some of the manufacturing and transportation costs. Reimbursement of these costs is designed to help offset some of the costs associated with processing and donating eligible dairy products.

Program details are available at www.ams.usda.gov/ddp. Interested partnerships must apply by completing and submitting a Dairy Donation and Distribution Plan. Upon plan approval, partnerships will be able to submit claims and supporting documentation to obtain reimbursement for eligible dairy products donated since January 1, 2020.



CT DAIRY FARMER PROMOTION GRANTS AVAILABLE

Connecticut Milk Promotion Board and New England Dairy are proud to announce that we are offering a competitive dairy promotion grant program to Connecticut dairy farm families and employees. Funding for this project was paid for by the Connecticut Milk Promotion Board.

This program is one more way to sustain a vibrant dairy community and champion the work of Connecticut dairy farm families. Funded projects will be eligible for grant funds of up to \$5,000 annually to improve public perception of dairy farming and/or increase consumption of local dairy products. The total grant funding available is \$20,000. Grants are available for projects that will be completed before May 13, 2022.
