## Connecticut Department of Agriculture Animal Population Control Programs See Record Response to Reduce Pet Overpopulation

Population Control Program (APCP) has received record response for their programs to reduce pet overpopulation. A change in statute now allows up to 20% (increased from 10%) of the yearly APCP income to be made available for the feral cat grant program, which assists Connecticut non-profit rescue groups with the sterilization and vaccination of feral cats.

Established in 1995, APCP has provided benefits to more than 250,000 animals and is funded by an annual surcharge on Connecticut dog licenses, the \$45.00 adoption fee, proceeds from the sale of the “Caring for Pets” commemorative license plates, and donations.

In fiscal year 2023, CT DoAg has received and issued a record number of applications from feral cat organizations for the feral cat grant program. More than 1,700 voucher requests were received with 1,480 vouchers issued for fiscal year 2023, up from 780 in fiscal year 2022. Since 2007, the APCP has averaged a 98% compliance rate for benefits issued through Connecticut non-profit organizations for feral cats.

Joan Lamont, Founder/President at C.A.T.S. Northeast, Inc. in North Windham has experienced the results of the feral cat program come full circle in her role at the rescue, as well as running a spay and neuter clinic, and as animal control officer for Windham. She shared, “It’s a great program and when utilized properly to spay and neuter an entire feral cat colony, the animals will no longer reproduce, helping to stop a rising cat overpopulation. We are already seeing a decreased need for vouchers in our area thanks to this program.”

“There is a demonstrated demand for the resources provided by the Animal Population Control Program, and this is an example of how a legislative proposal sought by the agency to make a difference is doing just that,” said Agriculture Commissioner Bryan P. Hurlburt. “We appreciate the opportunity to work with residents, non-profits, and participating veterinarians to reduce pet overpopulation and ensure animal health is maintained.”

The Animal Population Control Program also announces that the Low-Income Pet Sterilization Program has issued all available funds and will be closed for the remainder of the current fiscal year. This program helps CT residents to vaccinate and sterilize their pets using a participating Connecticut veterinary practice. To be eligible for benefits, recipients must be a Connecticut resident and on one of six public assistance programs outlined in C.G.S. Sec. 22-380e and approved by Department of Social Services. The Low-Income Pet Sterilization Program will reopen on November 1, 2023.

Spencer and Kristen Luthy of Maplewood Farm in Harwinton received a 2022 Farm Transition Grant to purchase a 2'x 6' flue evaporator with a steam hood for their sugarhouse. Established in 2016, Maplewood Farm focuses on high quality syrup production with a smaller product base of fresh eggs and vegetables. Their maple syrup operation began with just 45 taps and 11 gallons of syrup.

By 2021, their maple syrup operation had expanded to over 400 taps across 8 properties and production of 80 gallons of syrup per year. Looking to scale up to 500 taps in 2023 and 650 in 2024, Maplewood Farm realized that their existing evaporator was keeping them from achieving efficiency, scalability, and product diversity.



Installation of the new evaporator and steam hood has tripled their average boiling rate from 20 gallons an hour to 60. This increase in efficiency has contributed to the production of 60 additional gallons of syrup, raising annual production to 140 gallons.

By producing much greater quantities of maple syrup, the farm is not only able to supply their farmstand and five stores throughout the state, but also expand into other avenues of sale and acquire additional wholesale customers. As a result, Maplewood Farm's maple syrup has also been incorporated into a craft beer produced by Black Hog Brewery in Oxford, desserts made at an ice cream shop in Burlington, and cocktails at Continuum Distillery in Waterbury.

**This weekend, March 18 and 19, kicks off Maple Weekend in CT.** Many sugarhouses will be open for tours and selling their products. Maplewood Farm will be open for visitors on Saturday, March 18 from 1-5 p.m.

## FARMERS' MARKET NUTRITION PROGRAM MEETINGS FOR MARKET MANAGERS AND CERTIFIED FARMERS

Spring is here and that means our farmers' markets are preparing for another season. The Connecticut Department of Agriculture (CT DoAg) is looking forward to promoting your markets and providing outreach on benefits programs to increase participation.

What does that mean for our market managers? This year, through funding from the U.S. Department of Agriculture (USDA) Benefit Delivery Modernization Grant, the Farmers' Market Nutrition Program is transitioning to an electronic platform. To ensure a smooth transition, ALL market managers will need to attend one of our Market Manager Meet-ups before receiving their annual agreement to participate in the program.

Join us on April 10, 2023, at the Connecticut Ag Experiment Station Jones Auditorium in New Haven from 9:00 AM to 3:00 PM. Additional dates will be added.

We will go over listing your market with CT DoAg, eFMNP regulations and requirements, SNAP, doubling incentive programs, and more. The day will include a chance for new and seasoned farmers' market managers to network as well.

## FARMER CERTIFICATION & TRAINING

All fruit, vegetable, and honey producers selling at Certified Connecticut Grown

The certification allows farms to accept the FMNP benefits for only Connecticut Grown fresh fruits, vegetables, fresh-cut herbs, and eggs for WIC participants and income-eligible seniors over the age of 60. Seniors may also use their benefits for honey. Attend one of the below farmer certification meetings to become certified, learn about the SoliSYSTEMS platform, grant funds available, and accepting SNAP to expand sales.

**To ensure a smooth transition, ALL certified farmers, farmers' markets, and distribution partners will be required to attend an in-person training to participate in the program.**

## CONNECTICUT FARMER-TO-FARMER SOIL HEALTH COHORT PROGRAM

The New England Climate and Agriculture team at American Farmland Trust is offering a 1-year peer-to-peer soil health planning program for small-scale Connecticut farmers. Participants will:

- Receive \$2000 in financial assistance
- Build a community with other farmers
- Receive support from peers and service providers to craft a soil health plan for their own farm
- Learn from regional experts about the science and practice of building soil health, and planning approaches for soil health and climate adaptation
- Receive an on-farm visit from a soil health specialist
- Learn with a specialist how to collect soil health samples and complete a field soil health assessment

This course runs from September 2023-September 2024, with most program activities concentrated into the winter months. Most classes take place virtually on Zoom, with one scheduled one-on-one field visit and one group field trip to a local farm.

Participants who complete soil health plans that comply with the technical specifications required by NRCS will have the option to have their soil health plans submitted to their local NRCS office for cost-share consideration (financial assistance to implement the plan).

Space in this program is limited. Applicants will be selected based on interest, farm operation criteria, and best fit for the cohort. This program is not limited to but will prioritize small-scale producers, urban farmers, and farmers who have been historically underserved by USDA programs.

## CT FSA PROGRAM ENROLLMENT AND ANNOUNCEMENTS





## Pandemic Assistance Revenue Program

**Pandemic Assistance Revenue Program (PARP) enrollment opened Jan. 23, 2023 and runs through June 2, 2023.**

PARP will assist eligible producers of agricultural commodities who experienced revenue decreases in calendar year 2020 compared to 2018 or 2019 due to the COVID-19 pandemic. Producers who participated in previous USDA pandemic assistance programs may receive additional assistance through PARP if they exhibit a revenue loss after factoring in other payments.

### Who is Eligible?

PARP provides financial assistance for producers who suffered at least a 15% decrease in allowable gross revenue for the 2020 calendar year, as compared to 2018 or 2019. PARP helps address gaps in previous pandemic assistance, which was targeted at price loss or lack of market access, rather than overall revenue losses. Producers must meet additional FSA eligibility requirements including but not limited to AGI limitations.

**Emergency Relief Program (ERP) Phase Two enrollment opened Jan. 23, 2023 and runs through June 2, 2023.**

ERP Phase 2 is a tax year-based certification program that provides assistance for producers who suffered a loss in revenue due to necessary expenses associated with losses of eligible crops (excluding crops intended for grazing), due in whole or in part, to a qualifying disaster event that occurred in the 2020 or 2021 calendar year.

### Who is Eligible?

ERP Phase Two covers losses to crops, trees, bushes and vines due to a qualifying

crops intended for grazing. Qualifying natural disaster events include wildfires, hurricanes, floods, derechos, excessive heat, winter storms, freeze (including a polar vortex), smoke exposure, excessive moisture, qualifying drought, and related conditions. Producers must meet additional FSA eligibility requirements including but not limited to AGI limitations.

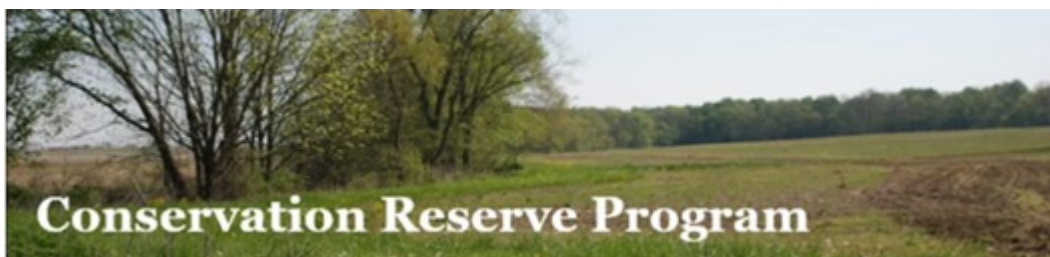
### **Food Safety Certification for Specialty Crops Program**

**Farm Service Agency will accept On-Farm Food Safety Expenses for Specialty Crop Growers (FSCSC) applications for calendar year 2023 from February 1, 2023, through January 31, 2024.**

**Enrollment for calendar year 2022 closed January 31, 2023.**

Did your specialty crop operation recently incur on-farm food safety program expenses related to obtaining or renewing a food safety certification in calendar years 2022 or 2023? You may be eligible for financial assistance through USDA's Food Safety Certification for Specialty Crops Program (FSCSC).

### **Conservation Reserve Program**

**Conservation Reserve Program (CRP) General Sign-ups open Feb. 27, 2023 and run through Apr. 7, 2023.**

In exchange for a yearly rental payment, farmers enrolled in CRP agree to remove environmentally sensitive land from agricultural production and plant species that will improve environmental health and quality. Contracts for land enrolled in CRP are from 10 to 15 years in length. The long-term goal of the program is to re-establish valuable land cover to help improve water quality, prevent soil erosion, and reduce loss of wildlife habitat.

conserving plant species, such as approved grasses or trees, to control soil erosion, improve water quality and enhance wildlife habitat on cropland. Additionally, General CRP includes a Climate-Smart Practice Incentive to help increase carbon sequestration and reduce greenhouse gas emissions by helping producers and landowners establish trees and permanent grasses, enhance wildlife habitat, and restore wetlands.

### Continuous CRP

In addition to the CRP general enrollment period, producers at any time can participate in CRP continuous enrollment period, in which producers can enroll the most environmentally sensitive land. Offers are automatically accepted provided the producer and land meet the eligibility requirements and the enrollment levels do not exceed the statutory cap. The Climate-Smart Practice Incentive is also available in the Continuous signup.

### GROWERS NEEDED FOR NANOTECHNOLOGY ADOPTION SURVEY

Carnegie Mellon University is seeking growers to participate in a survey about nanotechnology adoption. The project, titled **"Developing a Mental Model for Grower Agricultural Nanotechnology Adoption"**, is focused on understanding how growers who produce food for human consumption would think about adopting nanotechnology for agriculture.

The intent is to understand how growers think about this emerging type of technology so that it can be developed with their concerns and needs in mind. In brief, nanotechnology is being developed to deliver agrochemicals, like fertilizers and pesticides, more efficiently to reduce waste and improve farming efficiency. This study involves a semi-structured 40-minute interview conducted virtually via Zoom. There is no preparation necessary to participate in the interview and all published results will be de-identified to protect your privacy. There is no compensation for participating in this study. However, the information gathered is critical to the development of this new technology and your responses will help direct research and communication efforts moving forward.

## FOOD SAFETY PRACTICES SURVEY

The Produce Safety Alliance (PSA) Team and personnel from the Northeast Center to Advance Food Safety (NECAFS) at the University of Vermont would like to understand the costs and the barriers of beginning or expanding food safety practices on farms and in packinghouses to make educational materials more relevant to fruit and vegetable growers and packers. To do this, we have developed a survey to collect food safety information from fruit and vegetable growers across the country.

### What are the Goals of this Survey?

To understand:

- what steps growers have taken toward adopting food safety practices on their farm,
- the costs of adopting food safety practices (both one-time and reoccurring), and
- where growers have questions about food safety.

### Why Should You Participate?

The detailed information that is provided will allow future educational materials to be tailored to specific challenges that growers are facing.

### Who Should Participate?

We are looking for feedback from people involved in fruit and vegetable production and packing, including those who have and who have not adopted food safety practices. This survey should be completed by someone who has knowledge about the operation's produce safety practices (e.g., equipment, finances, supplies, training, market distribution, third-party audits).

Participation is voluntary and anonymous. It will take 10 – 30 minutes to complete the survey, depending on the farms' food safety practices.

By completing this survey, you can choose to be entered into a raffle to win a \$75 prepaid credit card. Ten participants will randomly be selected to win. The raffle will be held when the survey closes, approximately May 1st. If selected, you will be contacted to confirm your mailing address and acknowledge acceptance of the \$75 prepaid credit card.





## STILL TIME TO RESPOND TO THE 2022 CENSUS OF AGRICULTURE

Farmers and ranchers still have time to be counted in the 2022 Census of Agriculture, according to the U.S. Department of Agriculture's (USDA) National Agricultural Statistics Service (NASS). Although the deadline for submitting the ag census has just passed, NASS will continue to accept completed census questionnaires through the spring to ensure all farmers and ranchers take advantage of the opportunity to be represented in the widely used data.

NASS will continue to follow up with producers through the spring with mailings, phone calls, and personal visits. Farmers and ranchers are encouraged to complete their ag census either online at [agcounts.usda.gov](https://agcounts.usda.gov) or by mail as soon as possible.

Federal law under Title 7 USC 2204(g) Public Law 105-113 mandates that everyone who received the 2022 Census of Agriculture questionnaire complete and return it, even if they are not currently farming. The same law requires NASS to keep all submissions confidential, use the information for statistical purposes only, and publish aggregate data to prevent disclosing the identity of any individual producer or farm operation.

The National Association of State Departments of Agriculture Foundation is pleased to announce that the pre-application period of the NASDA Foundation - EPA Historically Underserved Farmers Grant application period is now open. The NASDA Foundation expects to award up to 16 sub-awards to organizations in the EPA's Ohio-Tennessee Region to help underserved farmers improve water quality, habitat resilience and information exchange to benefit Gulf of Mexico Watershed ecosystems. Awards are expected to range from \$75,000 to \$225,000 in total funds with a duration of up to three years. The pre-application period will run from March 1 – April 15, 2023.

The awards will be used to implement programs to prevent or reduce water pollution. The states within the Ohio-Tennessee region are Kentucky, Tennessee and portions of Indiana, Ohio, Pennsylvania, New York, West Virginia, Maryland, Virginia and North Carolina.

The following organizations and groups are encouraged to apply: beginning farmer organizations, conservation districts, institutions of higher learning, local state government agencies, non-government organizations and non-profit organizations with influence on underserved farmers, tribal nations, and veteran farmer and rancher groups.

Applicants will be notified in May 2023 if they are invited to complete the full application. Successful sub-awardees will be notified in July 2023 and projects will begin in August 2023.

“It is outstanding to see the state departments of agriculture collaborating with local organizations to communicate this opportunity to underserved farm communities,” NASDA Foundation Senior Director Chris Jones said. “I am excited about the continued partnerships these grants will help foster, the improvement of the Gulf of Mexico Watershed ecosystem, and the impact these projects will have on future generations.”

## USDA ANNOUNCES GRANTS FOR URBAN AGRICULTURE AND INNOVATIVE PRODUCTION

The U.S. Department of Agriculture (USDA) is making available up to \$7.5 million for grants through its Office of Urban Agriculture and Innovative Production (OUAIP). The competitive grants will support the development of urban agriculture and innovative production projects through two categories, Planning Projects and Implementation Projects. **USDA will accept applications on Grants.gov until 11:59 p.m. Eastern Time on March 27, 2023.**

### Planning Projects

Planning Projects initiate or expand efforts of farmers, gardeners, citizens, government officials, schools and other stakeholders in urban areas and suburbs. Projects may target areas of food access, education, business and start-up costs for

awarded funds to conduct a feasibility study and develop a business plan to establish a cooperative for small-scale agricultural producers serving low food access markets in Harris County, Texas.

### Implementation Projects

Implementation Projects accelerate existing and emerging models of urban, indoor and other agricultural practices that serve farmers and communities. Projects may improve local food access, include collaboration with partner organizations, and support infrastructure needs, emerging technologies, and educational endeavors. For example, the Moka Urban Agriculture Initiative used 2022 awarded funds for a project to increase local food access and provide culturally relevant options that create economic opportunities for urban farmers. The project will help to reduce food insecurity, improve health and establish outdoor spaces for food production in Missouri.

### More Information

OUAIP was established through the 2018 Farm Bill. It is led by the Natural Resources Conservation Service (NRCS) and works in partnership with numerous USDA agencies that support urban agriculture and innovative production. The grants are part of a broad USDA investment in urban agriculture. Other efforts include:

- Creating and managing a [Federal Advisory Committee for Urban Agriculture and Innovative Production](#) to advise the Secretary on the development of policies and outreach relating to urban agriculture.
- Reopening the [People's Garden Initiative](#). People's Gardens across the country grow fresh, healthy food and support resilient, local food systems; teach people how to garden using sustainable practices; and nurture habitat for pollinators and wildlife and greenspace for neighbors.
- Providing [cooperative agreements](#) that develop and test strategies for planning and implementing municipal compost plans and food waste reduction plans.
- Providing technical and financial assistance through conservation programs offered by [NRCS](#).
- Organizing 17 Farm Service Agency urban county committees.
