- 1. Call to Order: Commissioner Hurlburt called the meeting to order at 10:06 a.m. welcomed Council members and guests. Introductions were made.
- 2. Review and approval of Special Meeting Minutes of May 20, 2021. Jon Edwards motioned to accept. Linda Auger seconded. All in favor, motion passes.
- 3. Public Comment: none

Rebecca confirmed that the application is ready to distribute to wineries for participation and once again will pursue both tasting and pouring permits. Discussion ensued on changes/repairs to booth spaces, changes to ticketing credentials for exhibitors and storage fees. Rebecca asked winery board members for feedback on participation this year.
 - d. Research & Education: Richard Ruggiero stated that he will start working on developing a program. Discussion ensued on topics. Rebecca asked about a timeline. Will target a fall date for an educational session. Washington DaSilva gave an update on Spotted Lanternfly (SLF) and the quarantine order. Rebecca to send Jon Edwards a link with info to share at upcoming CVWA meeting. Jamie Jones relayed that 75% of management challenges are due to invasive pests.
