6. Board Member Updates

- a. Bryan Hurlburt (DOAG): Over the last 2 years transitioned to a digital FMNP, can enroll certified markets and farm stands. Have live data now and are able to identify communities with higher redemption rates and higher needs and can target pop up markets. Started the program in June. Put a stretch goal to increase redemption by \$250,000 and are within a few days of reaching the 1-million-dollar mark. Uncertainty what federal as well as state funding will look like soon.
- b. Marilyn (DPH): Farm to ECE Project: The mini-grant project with 16 ECE providers is nearing completion, featuring onsite gardens and partnerships with local farms for fresh produce. Holiday CSA shares to be delivered to these sites next week. Videos are being developed to showcase providers' successes and raise awareness of Farm to ECE. ECE Local Produce Procurement Survey: A survey conducted this summer assessed local food procurement practices among Connecticut ECEs, with a draft report under review. Key findings include High interest in local foods but challenges with cost, seasonal availability, and sourcing. Limited kitchen space and equipment hinder fresh food preparation. Gardens and food education are popular, with providers seeking additional gardening resources and funding. Recommendations include: Increased funding for local food. Developing farm connection resources. Facilitating access to CACFP and supporting providers with food preparation needs. Encouraging gardening by providing supplies, guidance, and partnerships with local agricultural experts.
- c. Tida (UW): Going to the Food insecurity event tomorrow, hosting a working session from 2:30-4pm to talk about Food is Medicine. Now leading advocacy and partnerships for UW.
- d. Monica (SDE): October is National Farm to School Month and CTG4CTK week so coming off a lot of engagement and promotion, collecting data and surveys. Looking to keep the momentum going for local purchasing all year.
- e. Molly (Highland Park): Pork strike is not over. Grocery prices coming down, seeing people coming into grocery store for lunch.
- f. Patrick (KNOX): Sat before thanksgiving is annual Harvest Market at KNOX
- g. Shawn (Brass City Harvest): Continiously having successful market, Liberated Land Cooperative wrapped up CSA and have a fundraiser going on now. Going after Growing Food Justice grant, did distribution in Waterbury, Hartford, and New Haven
