I. CALL TO ORDER

- II. APPROVAL OF JANUARY 9, 2014 MEETING MINUTES A motion was made by Susan Mitchell, seconded by Bill Davenport, to approve the minutes as submitted. The motion passed unanimously.
- III. REVIEW OF TOWN HALL MEETING Co-chair Kevin Sullivan reviewed the input received at the January 29, 2014, town hall meeting. A discussion ensued in response to the input.
- IV. STRATEGY FOR DEVELOPING DRAFT DELIVERABLES The group engaged in an in-depth discussion about its assignment and drew the following conclusions: the need for workforce training and internships at the high school and collegiate level has significance to the agricultural industry, however the infrastructure behind it is lacking. In addition the lack of job awareness and networking is preventing new farmers from emerging.
- VI. RECAP AND NEXT STEPS

It was determined a new section could be added to the Department of Agriculture's Connecticut Weekly Agricultural Report to address need for increase agricultural jobs. (This section was added to the publication subsequent to the meeting.) At the next meeting on March 20, 2014, the final recommendations will be determined.
