1. On May 23, 2023, the Commissioner issued an Order to Cease and Desist, Order to Make Restitution, Notice of Intent to Fine and Notice of Right to Hearing (collectively, “Notice”) against Matthew Craig Hults (“Respondent”), a copy of the Notice is attached hereto and incorporated by reference herein;
2. The Order to Cease and Desist and Order to Make Restitution provided that they would remain in effect and become permanent against Respondent if a hearing was not requested within 14 days of their receipt;
3. On May 23, 2023, the Notice was sent by certified mail, return receipt requested, to Respondent;
4. On July 28, 2023 the Notice was returned to the Department of Banking marked “RETURN TO SENDER – NOT DELIVERABLE AS ADDRESSED – UNABLE TO FORWARD”;
5. On June 27, 2023, the Notice was served on the Commissioner and, in accordance with Section 36b-33(h) of the General Statutes of Connecticut, Notice of Service on the Banking Commissioner in the matter of Matthew Craig Hults, dated June 27, 2023 (“Notice of Service”), was sent by certified mail, return receipt requested, to Respondent at 5871 Covington Cove Way, Orlando, Florida 32829;
6. Respondent has failed to request a hearing on the allegations set forth in the Order to Cease and Desist and Order to Make Restitution within 14 days of their receipt; and

7. On July 12, 2023, the Order to Cease and Desist and Order to Make Restitution issued against Respondent became permanent.
