The undersigned hereby certifies, on behalf of the Banking Commissioner (“Commissioner”), that:

1. On January 17, 2025, the Commissioner issued a Notice of Intent to Issue Stop Order Denying Effectiveness to a Business Opportunity Registration, Order to Cease and Desist (“Order”), and Notice of Right to Hearing against Anchored Tiny Homes Franchising LLC (“Respondent”) (collectively “Notice”), which Notice is attached hereto and incorporated by reference herein;
2. The Order provided that it would remain in effect and become permanent against Respondent if a hearing was not requested within 14 days of its receipt;
3. On January 21, 2025, the Notice was sent by certified mail (“Mailing 1”), return receipt requested, to Respondent;
4. On February 18, 2025, Mailing 1 was returned to the Department of Banking marked “Return to Sender –No Such Number, Unable to Forward”;
5. On February 19, 2025, the Notice was sent by certified mail (“Mailing 2”), return receipt requested, to Respondent at an additional address found for the Respondent after Mailing 1 was returned;
6. On March 5, 2025, Mailing 2 was returned to the Department of Banking marked “Return to Sender –Not Deliverable as Addressed, Unable to Forward”;
7. On March 14, 2025, the Notice was served on the Commissioner, and on March 14, 2025, in accordance with Section 36b-62(b) of the General Statutes of Connecticut, Notice of Service on the Banking Commissioner, dated March 14, 2025, the (“Notice of Service”), was sent by certified mail, return receipt requested, to Respondent at both addresses.
8. On April 2, 2025, both Notice of Services referenced above in paragraph seven (7) were returned to the Department of Banking marked “Return to Sender-Vacant- Unable to Forward”;

9. Respondent has failed to request a hearing on the matters set forth in the Order within 14 days of the date of the Notice of Service; and
10. On March 24, 2025, the Order issued against Respondent became permanent.
