Constant Observation Status. At this level of observation, staff shall visually observe the inmate on a continuous uninterrupted basis and document the inmate's behavior and general condition at 15-minute intervals utilizing Attachment E, Observation Checklist (HR-505). Constant Observation status shall be valid for a maximum of 8 hours, at which time the inmate must be re-evaluated for the need to continue <u>his/her</u> Constant Observation Status. <u>Staff</u> members assigned to conduct the Constant Observation must alternate with another staff member every two hours. At no time should an assigned staff member exceed more than two consecutive hours of inmate observation. Two staff members can be used for an extend time frame, as long as every two hours they switch assignments.
