It is recommended to remove the following language from Administrative Directive 10.9, Section 7F due the constitutional right of an individual to marry another person. Specifically, the language that is being proposed to be removed is, "  • Section 7 (F): "The inmate applicant shall be incarcerated for a minimum of one year and be discipline free for one year prior to the application before being approved for marriage/entry into a civil union. Inmates who are classified as security risk group members under the provisions of Administrative Directive 6.14, Security Risk Groups and 9.2, Offender Classification shall not be approved for marriage/entry into a civil union."
