This revision adds calendars to the list of identified publications and clarifies existing language.					
<ol> <li>Include the following language in A.D. 10.7 (4) (N) (see bold): <u>"Incoming Publications and Educational Materials.</u> Requests for any local orders for books, magazines, newspapers, calendars, educational materials or periodicals shall be made through the school principal or other person as designated by the Unit Administrator"</li> </ol>
