
Just a short way into the 40-minute long address, the Governor made the following statement, "Let me take a moment to thank

Governor's Speech Cont.

The Governor then continued, "My budget provides for the hiring of 125 new correction officers and additional staff. I also include money for new probation staff, a new warrant squad, youth violence prevention programs, substance abuse counselors and an array of inmate re-entry services."

Specifically, the governor's proposed budget adds more than \$25 million in 2009 to plug this year's fiscal holes and to meet that new sentencing requirement. That money also would cover rising costs tied to inmate housing, clothing, food, and medical treatment; add 22 parole officers; and cover costs tied to the opening of two quads at Carl Robinson Correctional Institution in Enfield.

"We are extremely grateful for the Governor's continued support of our agency," said Commissioner Theresa C. Lantz. "While the fiscal assistance is always important, her praise for our staff was the highlight of the speech for me and the department."

The budget proposal will now go before the General Assembly for its consideration. The final budget is to be adopted before this year's legislative session is adjourned the first week in May.

DOC in the Movies

distinction to the work and interests of the ACA and for service about and beyond the call of duty that the award is presented. He served as a United States Army Reserve Chaplain for 21 years and is one of only about 70 chaplains nationally to be certified by the American Correctional Chaplain's Association of which he serves as the current national president. Cheshire Facilities Join in Remembrance



On the night that the Town of Cheshire pierced the dark despair of last summer's tragic murders, with thousands of candles, the town's prominent correctional facilities were among those most deeply involved in the event. The "Lights of Hope Remembrance"

honored Jennifer Hawke-Petit and her two daughters who were killed during the home invasion. The memorial event sold luminary candles, which literally lit up the town's streets with signs of hope. The long front drive of the Cheshire Correctional Institution and its frontage along Route 10, as well as the entrances to Webster CI and Manson YI were fully illuminated by the candles. "I am very proud of how involved and committed this facility is to its host community," said Warden Charles Lee. The Department of Correction in fact, based on the level of support to the memorial, was one of only a few platinum sponsors for the event. In all more than \$100,000 was raised for Michaela's Miracle and Haley's Hope, foundations established by the Petit daughters to assist people with multiple sclerosis.

Radio Roundup

In March of 2007, the Director of Facilities Management & Engineering put together a committee to collaborate ideas and thoughts on implementing a new radio communication system. The main focus of the committee was to examine and evaluate the Department's communication needs and provide recommendations on future radio purchases. Based on this premise, a committee of fifteen (15) members were put together which included District Administrators, Tactical/Armory Operations Personnel, NP4 - Union, Engineering, MIS and District 1 Radio Specialists.

On April 13, 2007 the committee met for the first time and had an open discussion about the current EF Johnson radio system, its limitations and the future direction for the Agency. The committee agreed to purchase, field test and evaluate each manufacturer on the DAS contract capable of operating on the 800 MHz frequency. From this research five (5) manufacturers were

About the House Mouse

Mice have shared our homes (and our food) for centuries, and have migrated with our ancestors aboard ships throughout the world. No doubt our relationship with the creature commenced when humans began to farm and store grains. Since that time, the mouse has taken up residence in our silos, invaded our basements, and raided our kitchens. In fact, the scientific genus name for the mouse, *Mus*, is derived from the Sanskrit word meaning thief. But for all their troubling characteristics, it is hard not to admit that mice are cute, too. The animal has managed to burrow into our culture with such ambassadors as Stuart Little and, of course, Mickey.

As the outdoor temperature turns cooler, mice begin to seek the warmth of our homes. Even seemingly well sealed houses are susceptible to the mouse because they are exceptional climbers and can squeeze themselves through openings as small as a ¼ inch—about the diameter of a wood pencil.

Inspect around the house and fill in gaps such as found around outside faucets, basement windows, cable television cable entrances, and cracks in stone or brick foundations. Jammed steel wool covered with a silicone caulk works well in this application. Gaps under exterior doors should be sealed with weather stripping. Other preventative measures include blocking exhaust vents with hardware cloth and eliminating breeding areas like piles of leaves or old newspapers. Dirty pet food dishes also attract mice.

Once inside, mice can be trapped with baited spring traps, electronically activated traps and glue traps. Mice have poor eyesight and tend to scurry along walls, so traps placed along walls are more likely to be successful than traps placed away from walls. Mice are constantly recording the subconscious muscle patterns required to move between favorite locations. Therefore, disrupting the position of items before trap placement is a good strategy. Mice immediately explore their surroundings after landmarks are moved to store new files of muscle memories.

Mice have small movement territories and spend 70 percent of their time within a 12-foot circular area and over 90 percent of their time within a 30-foot circular area.

If you have fortified the house, and don't want the hassles involved with trapping, be aware that it has been shown that mice are discouraged by the scent of peppermint essential oil. A few drops of oil are applied to cotton balls, which are in turn placed around the protected area. The peppermint will remain an effective repellent for as long as the scent lingers. This varies according to conditions, of course, but good results should be obtained if new oil is supplied to the balls twice a month.

The peppermint oil helps keep mice away without the danger of poisoning pets and eliminates the need to handle repulsive traps or glue boards. As a bonus, the scent creates a very pleasant atmosphere for human inhabitants.

chosen; they were Tait, MA/COM, Kenwood, Motorola and EF Johnson. It was agreed that these radios would be field tested by staff at five (5) locations.

In May 2007, various subcommittees were formed to investigate current technology, gather field data, develop product review sheets, investigate product longevity, manufacturers warranty and technical support availability. On July 10, the committee gathered to discuss and approve equipment costs per manufacturer, facility test sites, and posts which would be utilized for the evaluation of the new radio equipment.

Prior to the onset of this radio project, the Department of Correction had been mandated by the Federal Communication Commission (FCC) to reprogram and reconfigure all of its 800 MHz equipment with the possibility of total replacement of our radio system, at no cost to the State of Connecticut. Unfortunately, the FCC ruled against the Agency. Additional negotiations are being held at this time regarding this ruling.

Based on the FCC ruling and an aggressive timetable, FM&E cut purchase orders in October 2007 for twenty (20) radios with accessories. The committee agreed to purchase four (4) radios from each of the five (5) manufacturers with all hardware, software, batteries etc. for evaluation.

On December 17, 2007 the committee met to examine each of the radios and provide comments. During this meeting a radio deployment schedule was provided which indicated the rotation of radios by facility. The facilities that were chosen to participate in this process were Robinson CI, MacDougall-Walker CI, York CI, Hartford CC and Tactical/Armory Operations.

Following the meeting all the radios were inventoried and delivered to the District 1 Radio Shop for software programming. It is anticipated that the complete rotation and testing of radios will conclude by March 24, 2008. In April of 2008 the committee will reconvene to review the staff evaluation sheets and determine a suitable replacement radio. The new radios will be rotated into District 1 facilities first. We anticipate the complete deployment of radios sometime in the fall of 2009.
