## **Governor Malloy Nominates Semple as Next Commissioner**

Governor Dannel P. Malloy on Wednesday, January 21, 2015 nominated Interim Department of Correction Commissioner Scott Semple to be the permanent head of the department.

Commissioner Semple has been serving as interim commissioner of the agency since August 2014 following the retirement of James E. Dzurenda from the position. His nomination will be reviewed first by the General Assembly's Executive and Legislative Nomination Committee, which would forward a recommendation to the General Assembly.

"Scott has extensive experience and knowledge of the inner workings of the Connecticut Department of Correction, including a number of years serving as a frontline correction officer," Malloy said in a press release

announcing the nomination, "gaining a broad familiarity on best practices in handling offenders and finding ways to reduce recidivism."

The Governor also praised Commissioner Semple for being "heavily involved" with enhancing supervision and treatment of the mental health prison population.

"I am humbled by this tremendous opportunity, and am truly grateful to Governor Malloy and Lieutenant Governor Wyman for placing their trust in me to lead the Department of Correction into the future," Commissioner Semple said of the nomination.

## **Seeking Hunter Scholarship Applicants**

The Association of State Correctional Administrators (ASCA) has announced that applications for the 2015 annual Susan M. Hunter Scholarship are now available. The scholarship is named in honor of Susan M. Hunter, former Director of the Prisons Division at the National Institute of Corrections, as a lasting tribute to her commitment to the field of corrections. Ms. Hunter was 53 when she passed away in 2004.

To be eligible for the scholarship, students must be the son or daughter of a corrections employee (current full-time, retired, or deceased) within an ASCA member department of corrections. Correctional employees, along with their siblings, spouses, and grandchildren, are not eligible.

Incoming first-time freshmen, along with enrolled full-time college and graduate students, must have a minimum high school GPA of 3.3. Graduate students' field of study must be Corrections/Criminal Justice. Students must be enrolled full-time in an accredited two-year or four-year college or university, or an accredited graduate program. Scholarship applications (and all required documentation) are due to the ASCA office on March 31, 2015 (postmarked no later than March 31, 2015). The Scholarship Review Committee will make its decisions in June 2015. Winners will be notified by phone. All other applicants will be notified via email. Scholarship recipients will be announced at the ASCA Summer Business Meeting in Indianapolis, Indiana.

### **Class 262 Graduates**

#### Warden Santiago Sworn In

As pre-service class sizes go, Class 262 was not the largest (only 47 members), yet despite their small size, the group's graduation ceremony, held January 8, 2015, at the Maloney Center for Training and Staff Development in Cheshire, was chockfull of special moments.

Some of the highlights included: a visit by newly re-elected Lieutenant Governor Nancy Wyman, a humorous speech by Connecticut Board of Pardon and Paroles Chairman Carleton Giles, as well as a moving tribute to recently departed members of the department's correctional family. Not to mention the swearing in of the department's newest Warden, Antonio Santiago.

Unlike many of the graduating classes, the composition of Class 262 did not consist primarily of correction officers. Some of the job titles that comprised Class 262 include: eight Substance Abuse Counselors, seven Food Service Supervisors, seven Chaplains, four Licensed Practical Nurses, three Registered Nurses, one Radiological Technician, and even one Locksmith.

Commissioner Scott Semple was first to address the graduating class. He encouraged them to have a plan, lead by example, continue their education and most importantly, stay focused.

Upon the conclusion of his remarks, Commissioner Semple introduced Lt. Governor Nancy Wyman, referring to her as a "true friend and supporter" of the Department of Correction. Lt. Governor Wyman made congratulatory remarks to Class 262, and then turned the podium over to guest speaker Carleton Giles.

After retiring as a 33-year veteran from the Norwalk Police Department, Chairman Giles urged those gathered

to, "work the job, don't let it work you." He also encouraged those gathered to not take themselves too seriously.

With all the graduates having made their way across the stage, having received their badges and back at their seats, Commissioner Semple officially swore in Preservice Class 262 as the newest members of the Department of Correction.

The focus of the ceremony then turned to the swearing in of Antonio Santiago of the Corrigan-Radgowski Correctional Center. With his wife and family joining him on stage, Warden Santiago appeared to beam with pride as he raised his right hand to take the oath.

MICHIGAN - Struggling with an acute shortage of correction officers the Michigan Department of Corrections will reinstate its state-funded recruit academy that was farmed out to community colleges 18 months ago.

WASHINGTON D.C. - The Supreme Court ruled recently in favor of the religious freedom claims of an Arkansas prisoner, who was blocked from growing a beard in accordance with his Muslim faith by the Department of Corrections. In a 9-0 opinion the Court ruled that part of the Arkansas prison policy violates a federal statute designed to protect the religious freedom of prisoners.

## Mentoring for the Health of It

Thanks to a first of its kind program in the nation, veteran correction officers at the Hartford Correctional Center (HCC) are helping officers who are just beginning their careers to cope with the unique pressures of working in a correctional facility.

A group of correction officers at the HCC trained with UConn staff in a program called the Health Improvement Through Employee Control II (HITEC-II), also referred to as the UConn DoC mentoring program, to become mentors to a group of officers who had recently graduated from the academy.

HITEC is a nationally unique research project directed to improve the health of correction personnel through activities that are designed and maintained directly by members of the workforce. HITEC II is a continuation of a study that began seven years ago called "HITEC I." In HITEC I, the health and wellness of correctional staff was assessed along with two different methods of health promotion interventions. HITEC II is an intervention study that builds on the findings of the previous work and consists of a mentoring program for new recruits, and two different participatory intervention activities. The study is planned to run until August 2016.

An interesting finding about the health of correctional staff was that, while new officers began their careers physically fit, within their first three years on the job their health deteriorated to a level similar to that of an officer who had been on the force for 15 or more

years. Their rates of high blood pressure, obesity and depression were comparable to more experienced officers. These findings raised the questions, "Why does this occur?" and "Can something be done in those first years that could help prevent this deterioration in health?"

To address these questions, HITEC II implements two interventions with new officers: a Web-based education site that provides information and self-paced learning modules about health and wellness, and a mentor program, which pairs a senior officer with a new officer. The mentor's role is not to teach the new officer the job but rather to assist the new officer in developing healthy ways of handling the stressors of the job.

The Hartford CC mentors belong to a group of 128 officers throughout the agency who have volunteered to act as mentors since the program's inception last summer. Mentors are paired with new officers at the training academy and remain in close contact throughout their first year of service.

The HITEC-II team recognizes the efforts of these mentors who are treading new ground and making a difference in the lives of their less experienced peers. This is the first program of its type in the nation, being run by officers for officers. Through their work with new officers, the mentors are creating a national example for building a healthier and safer correctional based workforce.

The veteran HCC staff members who are participating in the mentoring program include: Captain Raymond Howard who has dedicated generous amounts of time to organize mentoring efforts at the facility; Captain Timothy Newton; Lieutenant Brane Blackstock; and officers Joselito Bonilla, Joseph Carta, Samuel Ikem, Tamy Joyal, Marcos Narvaez, Kristen O'Brien, Craig Pelkey, Jose Santiago, Marzena Tasarz, Jeffery Valdez, and Edwin Vasquez.

Care and Share Holiday Food Drive to benefit Foodshare and the Connecticut Food Bank. Donating more than any other state agency, the

Department of Correction contributed more than 1/4 of the state total with an impressive \$5,309.80.

An annual part of the food drive is the Care & Share Charity Volleyball Tournament, which was held January 15 at the William O'Neill Armory. Various state agencies fielded a total of 51 teams to raise money for the food

drive. Congratulations to the Department of Correction's volleyball team from Central Office for going undefeated on route to winning the trophy.

In addition to the team from Central Office, teams from the Hartford Correctional Center, MacDougall-Walker Correctional Institution and the Carl Robinson Correctional Institution represented the agency in the tournament.

The donations will benefit Foodshare and the Connecticut Food Bank, the state's two largest food pantries and distribution organizations. This year, both organizations have seen an increase in the number of people asking for help. Many of those people, they say, are coming to food pantries for the first time.

## Fine Furninshings at Osborn CI

Osborn CI may be over 50 years old, but there is something brand new in the main corridor. It's a 10-foot long, 200-pound desk built by Vocational Instructor Joe Czech for the correction officers assigned to the Hall Keeper's post.

"Osborn is one of the oldest facilities in the state, but it does not have to look like one. In addition to a great deal of improved sanitation efforts and painting, a focus was placed on the Hall Keeper's work station. The craftsmanship and PRIDE of this facility and its staff is represented within this key post and piece of furniture, for all to see and appreciate. This is not a piece of furniture people would expect to see in such an aged facility," Warden Edward Maldonado said.



The Hall Keeper's post maintains the facility arteries running smoothly and is usually reserved for senior staff with considerable experience and facility knowledge.

"The Hall Keepers are in charge of maintaining and running the operation of the facility and coordinating all inmate movement. It's the focal point of operations in the facility, and that's a big job in the largest single building facility in the Northeast with over 2,000 inmates, and activities running from 5 a.m. to 10 p.m. daily," Warden Maldonado said.

The construction of the desk actually began this past summer when Warden Maldonado asked Vocational Instructor Czech to draft blueprints for the desk, and then to construct a prototype. Warden Maldonado wanted something to make a statement when seen and bring a positive and lasting impression to those visiting. Now the finished product is the focal point of the facility with emblems of all five branches of the United States military displayed as a way to honor correctional staff members who have served both domestically and overseas. Painted on the wall directly behind the desk is Osborn CI's new Mission Statement which reads:

The Osborn Correctional Institution recognizes its commitment to protecting the citizens of the State of Connecticut, its correctional staff, its victims, and its housed offenders alike. The Osborn Correctional Institution recognizes its stewardship, responsibility to act as a bridge builder in connecting resources and talent to meet the global mindset of the Connecticut Department of Correction. The Osborn Correctional Institution will strive to find new ways of creating globalization benefits for supporting and assisting with community re-integration.
