All Administrative Segregation Visits are Pre-Scheduled 72-hours in advance with Unit Management Staff

AS Phase II - Inmate shall be allowed two (2) 45-Minute Non-Contact visits per week, only with immediate family. No extended family visits.

AS Phase III - Inmate shall be allowed a minimum of three (3) 45-Minute visits per week. No extended family visits.

There are no visits on State Holidays (New Year's day, Martin Luther King Day, Lincoln's Birthday, Washington's Birthday, Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day and Christmas Day.

An inmate shall normally be allowed 2 social visits each week Monday through Friday and 1 visit every other weekend. No more than one social visit per day shall be allowed for any inmate. Visits are 45-minutes in duration.

AP unit inmate's shall normally be allowed 2 social visits each week Monday thru Friday and 1 visit EVERY weekend. No more than one social visit per day shall be allowed for any inmate. Every 4th Wednesday of the month morning visits are cancelled for Parole Hearings.
