Visitors must know what housing unit the offender is in prior to showing up at the facility. If the offender is not housed in the unit time slot, the visit will not be accommodated. It is the offender's responsibility to notify their visitor of building changes. It is recommended that visitors show up 15 minutes prior to the scheduled time slot for processing. 6:30 PM – 9:30 PM slot – Only 1 hour will be permitted during the open time frame. A total of 3 visitors are allowed for both in-person and video visits.

Video scheduled social visits are available by filling out a request on the Robinson CI website. Space is limited to ten computers. If an offender is scheduled for a video visit and the visitor shows up in person or another visitor for the same offender, the video visit will be honored only.

Photo Program – Photo Program – This visit will be set up with the Rec. Director (form submitted by the offender). Once approved and scheduled, it is the responsibly of the offender to notify his friends and family. Must be on the approved list for the scheduled day. Offenders will have a visit with their family at the tables as normal (1 hour), during that time the photographer will take pictures in the video visit area. Then will then return to the table for the remanding time of the visit.
