There are no social visits on Wednesdays or State observed Holidays (New Year's Day, Martin Luther King Day, Lincoln's Birthday, Washington's Birthday, Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day, and Christmas Day.

Acceptable Identification: a valid identification bearing the individual's photo including, but not limited a valid driver's license; non-driver identification card; state identification card; military identification card; passport (the only acceptable non-domestic form of identification is a passport issued from the visitor's country of origin);a Form I-551; Permanent Resident Card (i.e., green card). There are no exceptions to these identification requirements.

Check cashing and New Haven resident ID's are NOT acceptable forms of identification.

Each visitor may visit only once a day. An inmate may only have one visit per visiting block (no back to back visits). A Visit consists of no more than two (2) persons, including a child. Visitors must sign-up at least 15 minutes before the visiting session starts.

Children must be accompanied by an adult immediate family member who is on the inmate's approved visiting list; or accompanied by a member of the inmate's expanded family who is on the inmate's approved visiting list and who has obtained written permission to visit the inmate by the child's parent or legal guardian on CN 100601, Visiting Application; or accompanied by an authorized adult (i.e., an adult immediate family member who is on the approved visiting list, a legal guardian, an adult properly authorized by the Department of Children and Families, or an adult approved by the Unit Administrator). Children may not be left unattended in the lobby of the waiting area.
