The contract between FISH/Friends in Service to Humanity of Northwestern Connecticut, Inc. (the "Contractor") and the Department of Housing (the "Agency"), which was last executed by the parties on effective date: 07/14/15, is hereby further amended as follows:

- 1. The term of the contract is extended for an additional 2 years and the end date of the contract is changed from 06/30/16 to 06/30/18.
- 2. Part I, Section H.1.of the contract is amended because the total maximum amount payable under this contract has increased by \$436,249.00 from \$ 231,432.00 to \$667,682.00.
- 3. Part I, Section E. 9 shall be deleted in its entirety.
- 4. Part I, Section(s) G. 4. shall be deleted in its entirety.
- 5. Part I, Section(s) G. 7 shall be deleted and the following is substituted in lieu thereof:
 - g. Clients will complete a Client satisfaction survey *[for each separate program]* provided by the Contractor. A summary of these surveys will be presented to the Board of Directors and approved in the Board minutes. These minutes will be reviewed during the Department's annual visit.
- 6. Part I, Section H.1. of this contract, be deleted and the following is substituted in lieu thereof::
 - 1. **Payment Provisions.** The Agency agrees to pay for the services provided and as described under this contract up to a maximum amount not to exceed \$667,682.00, for the entire contract period.

7. The budget, Part I, Section H on page 13 of the contract is hereby deleted and the following is substituted in lieu thereof:

 - a. No budget revisions proposed by the Contractor may be submitted later than 45 calendar days <u>prior</u> to the end of each contract year during the contract period, except that the Department may entertain, at any time, a budget revision for the purpose of increasing funds solely for the audit of the Program. The final financial report will show all category overruns. Costs incurred after the end of the budget period will be disallowed except those which the Department has expressly approved in writing and in advance.
- 9. All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.
