Pursuant to Connecticut General Statutes Sections 13b-343, petitioners seeks to upgrade existing railroad appurtenances at the railroad crossing at Hamilton Street in Hartford by installing a new traffic signal and replacing the existing rail crossing surface and flashing lights and gates with all new equipment including a new pedestrian gate with flashing lights.

## In order to obtain PARTY STATUS:

1. A written petition must be submitted to the agency;

2. A copy of such petition must be mailed to all know parties (usually the Petitioner); and

3. The petition must state facts that demonstrate that the petitioner's LEGAL RIGHTS, DUTIES OR PRIVILEGES will be SPECIFICALLY AFFECTED by the agency's decision.

## In order to obtain INTERVENOR STATUS:

1. A written petition must be submitted to the agency;

2. A copy of such petition must be mailed to all known parties (usually the Petitioner) and

The petition must state facts that demonstrate that the Petitioner's participation is in the INTEREST OF JUSTICE AND WILL NOT IMPAIR THE ORDERLY CONDUCT OF THE PROCEEDING.

All petitions and certification of party notification must be received by this agency five (5) days prior to the date of hearing; otherwise such requested status shall be subject to denial.
