

# The State of Connecticut Department of Transportation Announces the Availability of the State's Draft Long-Range Transportation Plan



## What is Happening?

The Connecticut Department of Transportation has developed a draft Long-Range Transportation Plan for the State of Connecticut (2009 LRP) and is seeking your input. **The draft document will be available for public review beginning March 17, 2009**. The Department will be holding four public information meetings to present the draft 2009 LRP and receive comments on it. A final plan will be published in the spring of 2009.

#### What is the LRP?

The State's LRP is a federally mandated policy document that outlines strategies and actions for addressing transportation issues and needs in Connecticut. It is prepared in accordance with the provision of Title 23, Section 135 of the United States Code (U.S.C.), as amended by the Safe, Accountable, Flexible, Efficient Transportation Act: A Legacy for Users (SAFETEA-LU). It will serve as a framework for preparing future, more project-specific transportation plans such as the Department's Master Transportation Plan and the State Transportation Improvement Program. The LRP is generally updated every three to five years. This LRP covers the period from 2009 through 2035.

## Why Update the LRP?

Over time, changes occur in transportation needs, travel behavior, methods used to manage traffic, and the ability to pay for transportation system maintenance and improvements. The LRP is an important step toward reassessing Connecticut's policies for addressing our State's current and future mobility needs. It provides the framework for prioritizing projects and programs relating to Connecticut's transportation system.

## When Can I Provide Comments?

You may present your comments during the public information meeting or you may submit written comments by mail or electronically. Comments received by April 30, 2009, will be reviewed and considered as part of the process for preparing the final 2009 LRP.
