The purpose of the project is to protect steel members and preserve the condition of these steel bridges, thus extending their useful service life. This project is part of a statewide bridge coating program.

Right-of-way impacts associated with the proposed project are not anticipated.

Construction is anticipated to begin Spring 2025 based on the availability of funding. The estimated construction cost for this project is approximately \$30,000,000. This project is anticipated to be undertaken with 80% federal funds and 20% state funds.
