The purpose of this meeting is to provide the community an opportunity to learn about the proposed project and allow an open discussion of any views and comments concerning the proposed improvements. A Question & Answer (Q&A) session will immediately follow the presentation.

The purpose of the project is to rehabilitate Bridge Nos. 03015A and 03015B. The rehabilitation will repair steel, paint the structure, replace joints and deck/substructure patching.

Right-of-way impacts associated with the proposed project are not anticipated.

Construction is anticipated to begin Summer 2026 based on the availability of funding, acquisition of rights of way, and approval of permit(s). The estimated construction cost for this project is approximately \$29,600,000. This project is anticipated to be undertaken with 90 percent Federal funds and 10 percent State funds.
