## PUBLIC MEETING NOTICE

The Department of Transportation (Department) will conduct a Virtual Public Information Meeting concerning the proposed Replacement of Bridge No. 04070, Wire Mill Road over Haviland Brook on Thursday, March 18, 2021 at 7:00 p.m. The meeting will be live streamed via Microsoft Teams Live Event and YouTube Live. The project is identified as State Project No. 0135-0344.

The purpose of the project is to replace Bridge No. 04070, which is structurally deficient. The existing structure, built in 1957, is a single-span steel beam structure supported by reinforced concrete abutments and wingwalls. The total structure length is 25 feet and the curb-to-curb roadway width is 30.5 feet. The proposed replacement consists of a prestressed concrete deck unit structure supported by new concrete abutments. The proposed structure will have a clear span of 33 feet with a 30.5-foot curb-to-curb width consisting of two 11-foot travel lanes and 4.25-foot shoulders.

There are right-of-way impacts associated with the proposed improvements. Temporary and permanent ROW impacts are anticipated for this project. Minor property acquisitions in the form of a partial permanent take may be required for construction and future maintenance of the structure. Temporary construction easement will be required for construction as well as for inwater work downstream of the bridge.

Construction is anticipated to begin in Spring 2023 based on the availability of funding, acquisition of rights of way and approval of permit(s). The estimated construction cost for this project is approximately \$1,900,000. This project is anticipated to be undertaken with 80 percent Federal Funds and 20 percent Municipal funds.
