The purpose of the project is to address the existing structural deficiencies and the substandard minimum vertical clearance of Bridge No. 00848 with a full bridge replacement.

Right-of-way impacts associated with the proposed project are not anticipated.

Construction is anticipated to begin Summer 2025 based on the availability of funding and approval of permit(s).

The estimated construction cost for this project is approximately \$11,500,000. This project is anticipated to be undertaken with 80% federal funds and 20% state funds.
