APPLICATION 1910-RE-112-L RE-ENTITLEMENT OF AUTHORITY OF SKY TRANSPORTATION, LLC DBA SKY CAR SERVICE TO SKY TRANSPORTATION, LLC DBA SAFE TRANSPORTATION

INTRODUCTION

By application 1910-RE-112-L, filed with the Connecticut Department of Transportation (hereinafter "Department"), on October 8, 2019, Sky Transportation, LLC dba Sky Car Service (hereinafter "applicant") has re-entitled its authority to Sky Transportation, LLC dba Safe Transportation. Therefore, Livery Permit Number 3304 is amended and re-issued as follows:

<u>LIVERY PERMIT NO. 3304</u> FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Sky Transportation, LLC dba Safe Transportation is authorized to operate thirteen (13) motor vehicles, having a seating capacity of less than eleven (11) passengers, in general livery service from a headquarters in Newington.

RESTRICTIONS:

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend, or revoke said permit.

A memorandum of this permit, bearing the seal of the Department, shall be conspicuously posted in each motor vehicle operated under this permit.

DURATIONAL LIVERY SERVICE FOR THE PROVISION OF DURATIONAL TRANSPORTATION OF PASSENGERS FOR HIRE BY VIRTUE OF A CONTRACT WITH VEYO, LLC (FORMERLY LOGISTICARE SOLUTIONS, LLC) GRANTED IN DOCKET NO. 1307-GOV-303-L ON DECEMBER 16, 2013

Sky Transportation, LLC dba Safe Transportation is hereby permitted and authorized to operate three (3) motor vehicles having a seating capacity of less than eleven (11) passengers for the provision of livery service under contract with Veyo, LLC (formerly Logisticare Solutions, LLC) from a headquarters in Newington, Connecticut. The authority granted in Docket Number 1703-GOV-303-L shall be durational

in nature and shall exist only for the period of time that the permit holder has a current and continuing contract in effect for the provision of service with Veyo, LLC (formerly Logisticare Solutions, LLC).

The permit holder shall notify the Department of any termination of its contract with Veyo, LLC (formerly Logisticare Solutions, LLC) or the cessation of the active provision of service thereunder. The permit holder shall file with the Department on an annual basis, upon registration or re-registration of the motor vehicles authorized in this decision, a current, executed contract of said contract. Failure to file an extension of the contract or a new executed contract with Veyo, LLC (formerly Logisticare Solutions, LLC) shall void the authority for the vehicles authorized pursuant to that contract.

This permit is nontransferable and shall remain in effect until revoked by the Department or until the contract under which this authority is granted has expired. Failure of the permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other state statutes and/or rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend or revoke said permit.
