APPLICATION NO. (2005-TH-32-L) APPLICATION OF ACE TRANSPORTATION, LLC DBA ACE TRANSPORTATION, HOLDER OFLIVERY PERMIT NO. 2699, TO TRANSFER THEIR TWO (2) HEADQUARTERS FROM VERNON AND ENFIELD TO TOLLAND

I. APPLICANT'S PROPOSAL

By application 2005-TH-32-L, filed on May 28, 2020, pursuant to Section 13b-103 of the Connecticut General Statutes (CGS), Ace Transportation, LLC dba Ace Transportation (hereinafter "applicant"), holder of Livery Permit Number 2699, seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to transfer their TWO (2) headquarters from Vernon and Enfield to Tolland, and close the Vernon and Enfield headquarters. Specifically, to transfer:

- 1. Fourteen (14) motor vehicles, having a seating capacity of less than eleven (11) adults, in general livery service between all points in Connecticut from a headquarters in Enfield to a headquarters in Tolland.
- 2. Two (2) motor vehicles, each having a seating capacity of less than eleven (11) adults, in livery service for the transportation of Elderly and Handicapped persons between all points in Connecticut from a headquarters in Vernon to a headquarters in Tolland.
- 3. Two (2) motor vehicles, each having a seating capacity of less than eleven (11) passengers, for the provision of livery service under contract with Veyo, LLC (formerly Logisticare, Inc.) from a headquarters in Vernon to a headquarters in Tolland.
- 4. Nine (9) motor vehicles, each having a passenger seating capacity of less than eleven (11) passengers in livery service under contract with Veyo, LLC (formerly Logisticare, Inc.) between all points in Connecticut from a headquarters in Vernon to a headquarters in Tolland.
- 5. Three (3) motor vehicles, each having a seating capacity of less than eleven (11) passengers, for the provision of livery service under contract with Veyo, LLC (formerly Logisticare, Inc.) between all points in Connecticut from a headquarters in Vernon to a headquarters in Tolland.

II. <u>DEPARTMENT ANALYSIS</u>

A legal notice was mailed to registered livery companies in the headquarters towns and towns contiguous to its headquarters town and was not opposed within the thirty (30) days as allowed by statute. The Department's staff has analyzed the evidence presented in this instant application and finds that it should be granted without a hearing.

III. FINDINGS OF FACT

- 1. The applicant has submitted the proper application before this Department.
- 2. The Department finds that the applicant's records indicate all its vehicles have been in use and are available for transfer.
 - 3. No opposition was filed by existing operators in the headquarters town.

IV. CONCLUSION AND ORDER

Based on the above and pursuant to Section 13b-103, the instant application, given Application Number 2005-TH-32-L, filed by Ace Transportation, LLC dba Ace Transportation, is approved and Livery Permit Number 2699 is amended and reissued as follows:

LIVERY PERMIT NUMBER 2699 FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Ace Transportation, LLC dba Ace Transportation is hereby permitted and authorized to operate fourteen (14) motor vehicles, each having a seating capacity of less than eleven (11) adults, in general livery service between all points in Connecticut from a headquarters in **Tolland**.

Ace Transportation, LLC dba Ace Transportation is further permitted and authorized to operate two (2) motor vehicles, each having a seating capacity of less than eleven (11) adults, in livery service for the transportation of Elderly and Handicapped persons between all points in Connecticut from a headquarters in **Tolland**.

Ace Transportation, LLC dba Ace Transportation is further permitted and authorized to operate two (2) motor vehicles, each having a seating capacity of less than eleven (11) adults, for the provision of livery service under contract with Veyo, LLC (formerly Logisticare, Inc.) from a headquarters in **Tolland.**

RESTRICTIONS

The authority granted in Docket Number 9707-GOV-65-L shall be durational in nature and shall exist only for the time period that the permit holder has continuing contracts in effect for the provision of livery service with lower tier agents or directly with federal state or municipal agencies.

Pursuant to Docket Number 9707-GOV-65-L, the Permit holder shall notify the department of any termination of these contracts or cessation of active provision of service. To re-register additional vehicles authorized under this decision, the Permit holder shall certify a list of contracts for which this grant is made, that are in effect on such date (of registration).

The authority granted in Docket Number 9707-GOV-65-L is transferable by evidence that the transferee has qualifying contracts in place that meet the restriction in the decision or that the transferee is the successor to the contracts on which that grant was based.

This Permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the Permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend or revoke this Permit.

This Permit is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe.

A memorandum of this permit, bearing the seal of the department, shall be kept conspicuously posted in each motor vehicle operated under this permit.

Ace Transportation, LLC dba Ace Transportation is hereby permitted and authorized to operate nine (9) motor vehicles, each having a passenger seating capacity of less than eleven (11) adults, in livery service under contract, updated on February 1, 2013 with Veyo, LLC (formerly Logisticare Solutions, LLC), between all points in Connecticut from a headquarters in **Tolland.**

RESTRICTIONS

The authority for the nine (9) vehicles granted under contract with Veyo, LLC (formerly Logisticare Solutions, Inc.) shall be durational in nature and shall exist only for a period of time that the permit holder has a current and continuing contract in effect for the provision of service for non-emergency medical transportation in accordance with said contract.

The permit holder shall notify the Department of Transportation of any termination of this contract or the cessation of active provision of service thereunder. The Permit holder shall file with the Department on an annual basis, upon the registration or re-registration of the motor vehicles authorized in this decision, a current executed copy of the extension of said contract. Failure to file an extension of the contract or a new contract shall void the authority for all vehicles granted pursuant to this contract.

The authority granted under this decision, pursuant to said contract, is not transferable and shall remain in effect until revoked by the Department or until the contract under which this authority is granted has expired. Failure of the Permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other state statutes and/or the rules, regulations and orders of the department shall be considered sufficient cause to revoke said Permit.

A memorandum of this Permit, bearing the seal of the department, shall be kept conspicuously posted in each motor vehicle operated under this Permit.

RESTRICTIONS

The authority granted in Docket Number 0412-GOV-25-L shall be durational in nature and shall exist only for the time period that the Permit holder has continuing contracts in effect for the provision of livery service with lower tier agents or directly with federal, state or municipal agencies.

Pursuant to Docket Number 0412-GOV-25-L, the Permit holder shall notify the Department of any termination of these contracts or cessation of active provision of service. To re-register additional vehicles authorized under this decision, the Permit holder shall certify a list of the contracts, for which this grant is made, that are in effect on such date (of registration).

This Permit shall remain in effect until it is amended, suspended or revoked by the department. Failure of the Permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend or revoke this Permit

This Permit is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe thereunder.

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department.
