APPLICATION OF NEW HORIZONS, INC. DBA SUNSHINE WHEELS, HOLDER OF PERMIT NUMBER 3677, TO ADD A HEADQUARTER IN SIMSBURY

TO INCLUDE PREVIOUS AUTHORITIES LEFT OUT FROM THE LAST FINAL DECISION DATED NOVEMBER 3, 2020

FINAL DECISION

(Original decision November 3, 2020) November 23, 2020

I. INTRODUCTION

It was brought to the Department's attention on November 18, 2020 that the last final decision written for Permit 3677, application 2009-AH-50-L, was missing previous authorities. This final decision includes all previous authorities.

By application 2009-AH-50-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on September 28, 2020, New Horizons, Inc. dba Sunshine Wheels (hereinafter "applicant") made application to add an additional Headquarters in Simsbury.

The applicant, holder of Livery Permit No. 3677, is currently permitted and authorized to operate:

1. Six (6) motor vehicles, having a seating capacity of less than eleven (11) passengers, in General Livery service between all points in Connecticut from a headquarters in Farmington.

II. DEPARTMENT ANALYSIS

- 1. The applicant has submitted the proper application before the Department.
- 2. Department records indicate that all the existing vehicle(s) authorized are registered and in use.
- 3. No opposition was filed by existing operators in the Headquarter town.

III. FINDING OF FACT

1. After the Headquarter is granted, New Horizons Inc. dba Sunshine Wheels will immediately apply to add 2 (two) additional vehicles to the fleet which will be put in the new Simsbury Headquarters.

IV. CONCLUSION AND ORDER

Based on the above and pursuant to CGS Section 13b-103, this application is hereby approved and therefore Livery Permit Number 3677 is amended and reissued as follows:

LIVERY PERMIT NUMBER 3677 FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

New Horizons, Inc., dba Sunshine Wheels is hereby permitted and authorized to operate:

1. SIX (6) motor vehicles, having a seating capacity of less than eleven (11) passengers, in General Livery service between all points in Connecticut from a headquarters in Farmington.

2. Zero (0) motor vehicles, having a seating capacity of less than eleven (11) passengers, in General Livery service, between all points in Connecticut from a headquarters in Simsbury, awaiting the application for two additional vehicles without a hearing which shall be placed in the Simsbury headquarters.

RESTRICTIONS:

The authority granted in Application No. 1910-AV-109-L to add five (5) additional vehicles, making a total of six (6) vehicles, may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of decision which was 10/28/19. In addition, the applicant shall add 2 vehicles to Simsbury within 60 days or the Simsbury Headquarters granted in Application No. 2009-AH-50-L shall be revoked without the requirement of further notice from CTDOT.

This Permit shall remain in effect until revoked by the Department. Failure of the Permit Holder to maintain proper insurance and/or comply with all pertinent motor vehicles laws and other State statutes and/or the rules, regulations and orders of the Department shall be considered sufficient cause to revoke said Permit.

This Permit is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicles laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe thereunder.

A memorandum of this permit, bearing the seal of the Department, shall be kept conspicuously posted in the motor vehicle operated under this Permit.
